Beginning at an Iron Pin (rebar) set at the Southwest corner of said Lot 42; thence run North 05 degrees 50 minutes 00 seconds East a distance of 100.00 feet to an iron pin found at the Northwest corner of said Lot 42; thence run South 84 degrees 10 minutes 55 seconds East along the Northerly line of said Lot 42 a distance of 155.60 feet to an iron pin found; thence run South 05 degrees 50 minutes 00 seconds West a distance of 100.00 feet to an iron pin (rebar) set on the Southerly line of said Lot 42; thence run North 84 degrees 10 minutes 55 seconds West along the Southerly line of said Lot 42 a distance of 155.60 feet to the Place of Beginning, containing 0.357 acre, more or less.
