Commencing for reference at the Northwest corner of Lot No. 21 of the Sherwood Hills No. 2 Subdivision as recorded in Plat Book 13, Page 42, of the Muskingum County Plat Records; thence run South 85 degrees 39 minutes 26 seconds East (the basis of bearing for this description from Deed Book 1088, Page 312) a distance of 410.38 feet (by deed) to an iron pin (rebar) set at the Place of Beginning of the premises herein intended to be described (an existing iron pin (rebar) bears South 85 degrees 39 minutes 26 seconds East 83.40 feet); thence continue South 85 degrees 39 minutes 26 seconds East a distance of 99.62 feet to an iron pin (rebar) set at the Northwest corner of 2.078 Acres conveyed to C. William Grizzard (Deed Book 1052, Page 232); thence run South 08 degrees 32 minutes 07 seconds West along said Grizzard property a distance of 142.29 feet to an iron pin (rebar) set; thence run North 27 degrees 48 minutes 51 seconds West a distance of 167.62 feet to the Place of Beginning containing 0.162 acre, more or less.
