Being a part of the Northwest Quarter of Section Nine (9) and the Southwest Quarter of Section Two (2) in Township Eleven (11), Range Thirteen (13) of the Congress Lands East of the Scioto River and all of Parcel Three (3) and part of Parcel One (1) of Land Recorded in the name of Martha Ball, etal in Deed Book 971, Page 335 of the Muskingum County Deed Records bounded and described as follows:

Beginning at a stone found at the northwest corner of said northwest quarter of section 9; thence S 3° 28' 20" W (the base of bearings for this description is State Plane Grid from a Solar Observation) along the west line of said northwest quarter and along the west line of parcel 3 of said Martha Ball, etal and the east line of property owned by Muskingum River Gravel Co. (Vol. 392, pg. 346 - 1st parcel) a distance of 651.51 feet to a stone found and passing through an iron pin set at 420.77 feet; thence along the south line of said Parcel 3 of Martha Ball, etal and the north line of property owned by said Muskingum River Gravel Co. (Vol. 515, pg. 481) the following 3 courses and distances:
1 - S 87° 00' 42" E 396.00 feet to an iron pin set

2 - S 3° 28' 20" W 381.03 feet to an iron pin set

3 - N 85° 57' 45" E 820.80 feet to a 4" casing filled with concrete found and passing through an iron pin at 207.80 feet; thence along the east line of said Parcel 3 and the west line of said Muskingum River Gravel Co. (Vol. 451, pg. 550) N 2° 26' 25" E 932.15 feet to an iron pin set on the north line of said northwest quarter of section 9 and the south line of said southwest quarter of section 2 and passing through iron pins set at 234.82 feet and 611.63 feet; thence passing into the southwest quarter of section 2 and the first parcel of said Martha Ball, etal (Vol. 971, pg. 335) N 3° 30' 34" E 730.29 feet to an iron pin set and passing through an iron pin set at 398.00 feet; thence N 87° 00' 42" W 1193.00 feet to an iron pin set on the west line of said southwest quarter of section 2 and passing through an iron pin set at 559.12 feet; thence S 3° 30' 34" W along the west line of said southwest quarter and the east line of property owned by Donald and Janet Staker (Vol. 701, pg. 193) a distance of 730.29 feet to the place of beginning containing Forty-four and nine-hundredths (44.09) acres.

20.00 acres is part of Parcel 1 and part of Auditors Parcel No. 73-09-02-07-000.

24.09 acres is all of Parcel 3 and all of Auditors Parcel No. 73-78-09-04-000.

3 - N 20° 47' 48" W 66.40 feet


4 - N 30° 40' 49" W 107.56 feet


