SURVEY DESCRIPTION
 FOR
 Vicky Shields

Situated in the Northeast quarter of section #7, T-13, R-12, Wayne Township, Muskingum County, Ohio. Being a resurvey of the lands of Vicky Shields as recorded in Deed Book 1037 page 324 of the Muskingum County Deed records and being more particularly described as follows:

Commencing at a stone foud marking the Southeast corner of the Northeast quarter of section #7; thence, N.90°00'00"W. a distance of 633.49 feet along the South line of said quarter section to a set iron pipe, being the POINT OF BEGINNING; thence, N.90°00'00"W. a distance of 950.65 feet continuing along the the South line of said quarter section to a set iron pipe on the Southeast corner of C. & J. Myers (654/343); thence, N.04°20'41"E. a distance of 960.49 feet along the East line of said Myers lands to a point in the center of State Route #146, passing a set iron pipe at 935.49 feet; thence, S.64°56'08"E. a distance of 73.44 feet along the centerline of said road to a point; thence, S.50°06'39"E. a distance of 579.51 feet along the centerline of said road to a set rail road spike on the Northwest corner of R. Seybold (989/289); thence, S.33°29'30"E. a distance of 291.23 feet along the South line of said Seybold to a found iron pipe; thence, N.45°28'30"E. a distance of 80.55 feet along the East line of said Seybold to a point in the center of State Route #146; thence, S.44°28'21"E. a distance of 373.80 feet along the centerline of said road to a point on the Northwest corner of G. Burtnett (788/105); thence, S.54°04'00"W. a distance of 150.40 feet along the West line of said Burtnett lands to a found iron pipe, passing a set iron pipe at 25.00 feet; thence, S.32°00'00"E. a distance of 16.01 feet along the South line of said Burtnett lands to the point of beginning.

The above described parcel contains 13.103 acres, more or less, and is subject to all legal easements and right of ways. North is based upon record bearings in deed book 537 page 74. All set iron pins are 3/4" x 30" pipes with I.D. caps.



SURVEY PLAT FOR VICKY SHIELDS


