Beginning for reference at an iron pin found (5/8" harkness) at the southeast corner of the northwest quarter of said Section 7, thence in a northerly direction with the mid-section line, N 03°37'04" E a distance of 582.31 feet to a point on said mid-section section line, being the northeast corner of the lands now owned by Noah J. Forni & Michelle A. Forni (OR 2827-836), the principal place of beginning;

thence with the common line of said Forni/Reynolds' lands the following three (3) courses:

- 1. N 83°32'20" W a distance of 242.89 feet to an iron pin found (5/8" mcpeek);
- 2. N 88°53'30" W a distance of 145.40 feet to an iron pin found (5/8" mcpeek);
- 3. N 04°56'50" E a distance of 215.01 feet to a point in the center of Lutz Lane (C-483), passing an iron pin found (5/8" mcpeek) at 180.66 feet;

thence with the center of said Lutz Lane the following six (6) courses:

- 1. N 87°24'53" E a distance of 135.97 feet to a point;
- 2. S 89°20'56" E a distance of 94.47 feet to a point;
- 3. S 80°04'35" E a distance of 54.81 feet to a point;
- 4. S 72°15'38" E a distance of 44.74 feet to a point;
- 5. S 65°16'01" E a distance of 51.05 feet to a point;
 6. S 61°08'14" E a distance of 8.68 feet to a point on said mid-section line;

thence with said mid-section line, S 03°37'04" W a distance of 201.18 feet to the principal place of beginning, containing a total of +/- 1.970 acres, more or less, subject to all legal highways and easements of record.
