

Being a part of the Northeast Quarter of Section 10, Township 12, Range 15, of the Congress Lands East of the Scioto River, Wayne Township, Muskingum County, Ohio

Beginning at a point marked by an iron pin (3/4 inch pipe) at the Southeast Corner of Lot number 8 of Liggitt Subdivision as recorded in Plat Book 12, page 67 of the Muskingum County Plat Records, said point being East 100.00 feet from a point marked by an existing iron pin (3/4 pipe) at the Southwest Corner of said Lot number 8; thence North 00 degrees 01 minute 11 seconds West 598.16 feet along the East line of Lots number 8, 9, 10, and 11 of said Liggitt Subdivision to a point marked by an iron pin (3/4 inch pipe) on the South right-of-way line of State Route 140 at the Northeast Corner of Lot number 11, passing a point marked by an existing iron pin (3/4 inch pipe) at 589.46 feet; thence South 80 degrees 49 minutes 20 seconds East 50.00 feet along the south right-of-way line of State Route 140 to a point marked by an iron pin (3/4 inch pipe); thence South 00 degrees 01 minute 11 seconds East 585.39 feet to a point marked by an iron pin (3/4 inch pipe); thence West 78.97 feet to the place of beginning.

Containing 1.073 more or less acres.

Subject to a 20 foot right-of-way or Easement for Ingress and Egress as recorded in Volume 682 page 171.

Also a 20 foot right of Ingress and Egress as recorded in Volume 819 page 255.


