SURVEY DESCRIPTION
FOR
A. DALE ARCHER

Situated in the Northwest quarter of Section #10, Quarter Township #1, T-12-N, R-13-W, Wayne Township, Muskingum County, Ohio. Being the lands of A. Dale Archer as conveyed in Deed book 747, page 25 Muskingum County Deed records and being more particularly described as follows:

Commencing at the Southwest corner of the Northwest quarter of section #10; thence, S.86°35'00"E. a distance of 262.00 feet along the South line of said quarter to the Southwest corner of M. Ginikos (748/20); thence, N.09°43'00"E. a distance of 443.41 feet along the west line of said Ginikos lands to a set iron pin, BEING THE POINT BEGINNING; thence, N.09°43'00"E. a distance of 280.06 feet along the East line of G. Winters (962/249) to a point in the center of State Route #146, passing a set iron pin at 249.99'; thence, S.84°10'21"E. a distance of 173.30 feet along the centerline of said route to a point; thence, S.07°40'00"W. a distance of 276.38 feet along the West line of R. Pyle (907/270) to a set iron pin, passing a set iron pin at 30.01'; thence, N.85°10'00"W. a distance of 183.45 feet along the North line of M. Ginikos (784/020) to the THE POINT OF BEGINNING.

The above described parcel contains 1.137 acres, more or less, and is subject to all legal easements and right of ways. North is based upon record bearings in Deed Book 747 page 025. All set iron pins are 3/4" x 30" pipes with I.D. caps.




