BEGINNING AT AN IRON PIN FOUND MARKING THE NORTHEAST CORNER OF LOT #33 OF THE BAM SUBDIVISION AS RECORDED IN PLAT FILE 1 NUMBERS 98B, 99, 99B IN THE MUSKINGUM COUNTY RECORDER'S OFFICE, SAID POINT BEING ON THE WESTERLY LINE OF FAIRNTOSH ESTATES #3 AS FOUND IN PLAT BOOK 12 PAGE 36 IN THE MUSKINGUM COUNTY RECORDER'S OFFICE, THENCE WITH THE NORTHERLY LINE OF LOT #33 S 63° 57'23" W 71.68 FEET TO AN IRON PIN SET AND BEING THE PRINCIPLE PLACE OF BEGINNING OF THE TRACT HERE IN TO BE DESCRIBED:

THENCE, CONTINUING WITH THE NORTHERLY LINE OF LOT #33 S 63°57'23" W 99.50 FEET TO A P.K. NAIL SET IN THE CENTERLINE OF BAM LANE (50' WIDE) BASSING OVER A REFERENCE IRON PIN FOUND AT 74.50 FEET:

THENCE, WITH THE CENTERLINE OF BAM LANE (50' WIDE) N 26°02'37" W 212.84 FEET TO A P.K. NAIL SET MARKING THE INTERSECTION OF BAM LANE AND DEITZ LANE (40' WIDE):

THENCE, WITH THE CENTERLINE OF DEITZ LANE (40' WIDE) N 63°57'23" E 95.64 FEET TO A P.K. NAIL SET:

THENCE, WITH A NEW LINE THROUGH THE MILL PARCEL S 27" 04'57" E 212.88 FEET TO THE PLACE OF BEGINNING, PASSING OVER A REFERENCE IRON PIN SET AT 20.00 FEET. THE TRACT AS SURVEYED CONTAINS 0.4767 ACRES, OF WHICH 0.1547 ACRES ARE LOCATED IN THE RIGHT-OF-WAYS OF BAM LANE AND DEITZ LANE MORE OR LESS, SUBJECT TO ALL LEGAL EASEMENTS OF RECORD.


