COMMENCING AT AN IRON PIN FOUND AT THE NORTHEAST CORNER OF THE SOUTHEAST QUARTER OF SAID SECTION 15, THENCE, SOUTH OO DEGREES - 45 MINUTES - 00 SECONDS WEST, 1114.98 FEET TO AN IRON PIN SET ON THE WEST LINE OF SECTION 15 AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, CONTINUING SOUTH OO DEGREES - 45 MINUTES - 00 SECONDS WEST, 1024.00 FEET TO A POINT FROM WHICH AN IRON PIN BEARS NORTH 60 DEGREES - 59 MINUTES - 53 SECONDS EAST, 2.11 FEET PASSING AN IRON PIN FOUND AT 686.45 FEET; THENCE, LEAVING SAID SECTION LINE SOUTH 60 DEGREES - 59 MINUTES - 53 SECONDS WEST, 2564.47 FEET TO IRON PIN FOUND; THENCE, NORTH 29 DEGREES - 11 MINUTES - 35 SECONDS WEST, 208.00 FEET TO AN AXLE FOUND; THENCE, NORTH 59 DEGREES - 11 MINUTES - 23 SECONDS EAST, 488.71 FEET TO A POINT; THENCE, NORTH 25 DEGREES - 14 MINUTES - 07 SECONDS WEST, 212.45 FEET TO AN IRON PIN FOUND; THENCE, SOUTH 59 DEGREES - 11 MINUTES - 19 SECONDS WEST, 859.62 FEET TO A POINT ON THE WEST SIDE OF STATE ROUTE 60 PASSING AN IRON PIN FOUND AT 709.62 FEET; THENCE, NORTH 11 DEGREES - 31 MINUTES - 18 SECONDS WEST, 104.86 FEET TO A POINT; THENCE, NORTH 54 DEGREES - 36 MINUTES - 22 SECONDS EAST, 319.84 FEET TO THE POINT OF BEGINNING AND CONTAINING 43.858 TOTAL ACRES OF WHICH 33.238 ACRES LIES IN SECTION 15 AND 10.620 ACRES LIES IN SECTION 5.
