SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, TOWNSHIP OF WAYNE, AND BEING PART OF THE SOUTHEAST QUARTER OF SECTION 14, TOWNSHIP 12, RANGE 13, AND BEING PART OF THOSE LANDS INTENDED TO BE DESCRIBED IN DEED VOLUME 1111, PAGE 483; BEING FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

COMMENCING AT THE NORTHWEST CORNER OF SAID SOUTHEAST QUARTER OF SECTION 14, THENCE, NORTH 89 DEGREES - 59 MINUTES - 50 SECONDS EAST, 732.02 FEET TO AN IRON PIN FOUND; THENCE, SOUTH 00 DEGREES - 29 MINUTES - 43 SECONDS WEST, 145.20 FEET TO A POINT IN THE CENTER OF TOWNSHIP ROAD \$449, AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED, PASSING AN IRON PIN FOUND AT 120.20 FEET; THENCE, ALONG THE CENTERLINE OF SAID ROAD, THE POLLOWING FOUR (4) COURSES AND DISTANCES:

- 1) SOUTH 57 DEGREES 33 MINUTES 41 SECONDS EAST, 182.59 PEET TO A
- 2) SOUTH 66 DEGREES 31 MINUTES 52 SECONDS EAST, 78.75 FEET TO A
- 3) SOUTH 79 DEGREES 30 MINUTES 39 SECONDS EAST, 125.37 FEET TO A
- 4) SOUTH 82 DEGREES 32 MINUTES 57 SECONDS EAST, 238.57 FEET TO A POINT;

THENCE, LEAVING SAID ROAD, SOUTH OO DEGREES - 21 MINUTES - 52 SECONDS WEST, 544.94 FEBT TO AN IRON PIN SET, PASSING AN IRON PIN SET AT 30.00 FEET; THENCE, NORTH 89 DEGREES - 30 MINUTES - 17 SECONDS WEST, 588.98 FEET TO A POINT IN THE CENTER OF COUNTY ROAD #449, PASSING AN IRON PIN SET AT 573.98 FEET; THENCE, NORTH OO DEGREES - 29 MINUTES - 43 SECONDS EAST, 722.93 FEET TO THE POINT OF BEGINNING, PASSING AN IRON PIN FOUND AT 147.47 FEET, AND AN IRON PIN SET AT 707.93 FEET, AND CONTAINING 8.123
