DEED DESCRIPTION

Situated in the State of Ohio, County of Muskingum, Township of Wayne, T-12, R-13, being a resurvey of Charles W. Frick Vol. 1056 Pg. 147, being part of Sections 4 & 14, and more particularly described as follows:

Beginning at a stone at the Southwest Corner of the Southeast Quarter of Section 14; thence North 02 Degrees 22 Minutes 02 Seconds East 1503.51 feet to a stone; thence South 88 Degrees 43 Minutes 12 Seconds East 761.59 feet to a point in Twp. Rd. 627, passing an iron pin found at 731.59 feet; thence along said Twp. Rd. the next 7 courses to points; South 02 Degrees 39 Minutes 38 Seconds West 1105.31 feet; thence South 02 Degrees 09 Minutes 22 Seconds East 43.07 feet; thence South 16 Degrees 33 Minutes 34 Seconds East 49.82 feet; thence South 30 Degrees 54 Minutes 55 Seconds East 57.47 feet; thence South 40 Degrees 41 Minutes 34 Seconds East 153.46 feat; thence South 42 Degrees 00 Minutes 51 Seconds East 193,73 feet; thence South 30 Degrees 42 Minutes 35 Seconds East 15.62 feet to a railroad spike set on the North line of Section 4; thence leaving said road along the North line of Section 4 South 88 Degrees 13 Minutes 26 Seconds East 202.43 feet to an iron pin set; thence South 01 Degrees 36 Minutes 13 Seconds West 666.95 feet to a stone found; thence North 88 Degrees 44 Minutes 59 Seconds West 1245.36 feet to an iron pin set, passing a railroad spike set in Twp. Rd. 627 at 287.16 feet and an iron pin found at 729.27 feet; thence North 00 Degrees 31 Minutes 11 Seconds East 678.54 feet to the place of beginning, containing 46.68 total acres, being 27.35 acree in Section 14 and 19.33 acres in Section 4, more or less, subject to all legal highways and easements.




