SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, TOWNSHIP OF WAYNE, AND BEING PART OF THE SOUTHEAST QUARTER OF SECTION 12, TOWNSHIP 12, RANGE 13, AND BEING PART OF THOSE LANDS INTENDED TO BE DESCRIBED IN DEED VOLUME 682, PAGE 135; BEING FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

COMMENCING AT THE NORTHEAST CORNER OF THE SOUTHEAST QUARTER OF SECTION 12, THENCE, SOUTH 89 DEGREES - 32 MINUTES - 12 SECONDS WEST, 872.71 FEET TO A POINT; THENCE, SOUTH 00 DEGREES - 14 MINUTES - 07 SECONDS EAST, 1305.04 FEET TO AN IRON PIN; THENCE, CONTINUING SOUTH 00 DEGREES - 14 MINUTES - 07 SECONDS EAST, 63.99 FEET TO AN IRON PIN; THENCE, SOUTH 89 DEGREES - 45 MINUTES - 58 SECONDS WEST, 60.72 FEET TO A STONE; THENCE, SOUTH 00 DEGREES - 04 MINUTES - 43 SECONDS EAST, 287.97 FEET TO AN IRON PIN FOUND; THENCE, SOUTH 89 DEGREES - 19 MINUTES - 58 SECONDS WEST, 160.43 FEET TO A POINT IN THE CENTER OF WAYNE RIDGE ROAD, AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, CONTINUING SOUTH 89 DEGREES - 19 MINUTES - 58 SECONDS WEST, 866.57 FEET TO A STONE, PASSING A STEEL POST AT 193.91 FEET; THENCE, NORTH 00 DEGREES - 16 MINUTES - 16 SECONDS WEST, 215.87 FEET TO AN IRON PIN; THENCE, NORTH 44 DEGREES - 22 MINUTES - 03 SECONDS EAST, 345.02 FEET TO A POINT IN THE CENTER OF WAYNE RIDGE ROAD, PASSING AN IRON PIN AT 328.21 FEET; THENCE, ALONG THE CENTER OF SAID WAYNE RIDGE ROAD, THE FOLLOWING FOURTEEN (14) COURSES AND DISTANCES:


