

DESCRIPTION OF SURVEY FOR LURA K WINTERS ESTATE JOB#2744-1

- #14- **THENCE South 79 degrees 26 minutes 37 seconds East 505.32 feet** along said Winters and Mill properties to an iron pin (set);
- #15- **THENCE North 22 degrees 30 minutes 07 seconds East 1016.37 feet** continuing along said properties to an iron pin (found capped 6885);
- #16- **THENCE North 71 degrees 18 minutes 25 seconds West 364.25 feet** continuing along said properties to an iron pin (found capped 6885) in the centerline of an access easement 16 feet wide recorded in Deed Book 260, Page 185 and later widen to 60 feet and recorded in Deed Book Volume 997, Page 68, passing an iron pin (found) at 287.33 feet;
- #17- **THENCE North 46 degrees 34 minutes 23 seconds East 179.17 feet** along the centerline of said access easement and continuing along said properties to an unmarked corner of the Cody Ore property recorded in Official Record Volume 2799, Page 145;
- #18- **THENCE South 58 degrees 12 minutes 50 seconds East 294.43 feet** leaving said easement and along a line of said Cody Ore property to an iron pin (found capped 6885), passing an iron pin (found capped 6885) at 32.43 feet;
- #19- **THENCE North 23 degrees 30 minutes 02 seconds East 141.85 feet** continuing along said Cody Ore property to an iron pin (found capped 6885) at a corner of a 0.37 acre parcel surveyed from said Winters property and to date not recorded;
- #20- **THENCE North 46 degrees 12 minutes 38 seconds West 229.99 feet** along a common line for said Cody Ore and 0.37 acre parcel to an unmarked point in the centerline of said access easement, passing an iron pin (found capped 6885) at 213.44 feet;
- #21- **THENCE North 35 degrees 10 minutes 59 seconds East 29.29 feet with a curve to the left having, a radius of 158.41 feet, and arc length of 29.33 feet** along said access easement, Mill property, and 0.37 acre parcel to an unmarked corner of the Quintin B Ore property recorded in Deed Book Volume 1019, Page 541;
- #22- **THENCE South 70 degrees 22 minutes 24 seconds East 209.85 feet** leaving said access easement and along a common line for said 0.39 acre parcel and Quintin B Ore property to an iron pin (found capped 6885), passing an iron pin (found capped 6885) at 30.41 feet;
- #23- **THENCE North 04 degrees 14 minutes 14 seconds East 380.59 feet** along a common line for said Winters and Quintin Ore properties to an iron pipe (found);
- #24- **THENCE North 87 degrees 47 minutes 23 seconds West 204.31 feet** continuing along said properties to an unmarked point in the centerline of said access easement, passing an iron pipe (found) at 174.28 feet;
- #25- **THENCE North 04 degrees 10 minutes 51 seconds East 117.70 feet** along said access easement and common line for said Winters property and a second Quintin B Ore property recorded in Deed Book Volume 1110, Page 617 to an unmarked point on the common line for the Northwest and Southwest Quarters of Section 9, passing iron pipes (found) at 60.03 feet and 110.54 feet;
- #26- **THENCE South 87 degrees 17 minutes 36 seconds East 909.05 feet** leaving said access easement, along said Quarter Section line, and common line for said Winters property and for a second William K Mill and Amy L Mill property recorded in Official Record Volume 1536, Page 207, and the Kimberly Mortimer property recorded in Official Record Volume 1932, Page 608, and the Howard Richard Kirkbride property recorded in Official Record Volume 1936, Page 352 to an iron pin (found capped 6885) at a corner of the Denise E Winters Trustee property recorded in Official Record Volume 2871, Page 843, passing an iron pin (set) at 25.07 feet, and iron pin (found) at 394.00 feet;
