**Legal Description**  
**0.633 ACRES**

Situated in the Township of Wayne, County of Muskingum, State of Ohio, and being a part of Fractional Section 5, Township 11N, Range 13W, and being more particularly described as follows;

Being a Survey of a part of a 7.72 acre parcel conveyed to Russell E. Bauserman, as recorded in Volume 1797, Page 823, in the Muskingum County Deed Records, and being part of Auditor's Parcel No. 73-48-01-20-000, and being further described as follows;

Commencing at an iron pin found marking the Southeast corner of the Northeast Quarter of Section 5 (by Deed);  
27"

Thence, N 82°28' W 1527.55 feet with the South Line of said Quarter Section, to a 5/8" o.d. iron pin found on the South line of said 7.72 acre parcel of which this description is a part;

Thence, N 17°05'36" W 206.53 feet to an iron pin set on the West line of said 7.72 acre parcel, the same being the East line of a 3.14 acre parcel conveyed to Robert W. & Pamela S. Edwards, as recorded in Volume 1766, Page 949, and being the PRINCIPLE PLACE OF BEGINNING of the 0.633 acre parcel herein to be described;

Thence, N 17°05'36" W 275.97 feet continuing with the boundary of said 7.72 acre parcel, the same being the East line of said parcel conveyed to Edwards, to a 5/8" o.d. iron pin found marking the Northwest corner of said 7.72 acre parcel, and being on the South line of a parcel conveyed to Frial Dietz, as recorded in Volume 1088, Page 352;

Thence, N 81°59'00" E 104.19 feet with the North line of said 7.72 acre parcel of which this description is a part, the same being the South line of said parcel conveyed to Dietz, to an axle found;

Thence with a line across said 7.72 acre parcel of which this description is a part, with the following two (2) courses and distances:

- 1) S 16°42'35" E 264.81 feet to an iron pin set;
- 2) S 75°53'29" W 101.25 feet to the PRINCIPLE PLACE OF BEGINNING.

Said parcel as surveyed contains 0.633 acres, more or less, and subject to all legal easements, right of ways, restrictions, and zoning ordinances of record.

Subject to a 20 foot wide ingress/egress easement with the centerline being the entire West line of the above described 0.633 acre parcel.

Bearings of the above description are based on the South line of the Northeast Quarter of Section 5 as being N 82°07'00" W, and is an assumed Meridian used to denote angles only.

All iron pins set are 5/8" o.d. iron pins 30" long with yellow caps labeled "S.A. ENGLAND #S-7452".


