DESCRIPTION FOR CONVEYANCE

BEING A PART OF THE NORTHEAST QUARTER OF SECTION 3, TOWNSHIP 11, RANGE 13, CONGRESS LANDS EAST OF THE SCIOTO RIVER, WAYNE TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

COMMENCING AT AN EXISTING 5/8 INCH REBAR AT THE SOUTHWEST CORNER OF THE NORTHEAST QUARTER OF SECTION 3; THENCE NORTH 00 DEGREES 40 MINUTES 21 SECONDS EAST 597.17 FEET ALONG THE WEST LINE OF SAID QUARTER TO AN EXISTING 5/8 INCH REBAR, SAID REBAR BEING THE PLACE OF BEGINNING OF THIS TRACT; THENCE CONTINUING ALONG SAID WEST LINE OF THE NORTHEAST QUARTER NORTH 00 DEGREES 40 MINUTES 21 SECONDS EAST 107.74 FEET TO AN IRON PIN SET; THENCE SOUTH 85 DEGREES 34 MINUTES 13 SECONDS EAST 570.74 FEET TO THE CENTER OF TOWNSHIP ROAD NUMBER 238 (LAWHEAD LANE), PASSING AN IRON PIN SET AT 545.74 FEET; THENCE SOUTH 04 DEGREES 24 MINUTES 27 SECONDS WEST 107.51 FEET TO THE CENTER; THENCE LEAVING SAID CENTER NORTH 85 DEGREES 34 MINUTES 13 SECONDS WEST 563.72 FEET TO THE PLACE OF BEGINNING, PASSING EXISTING 5/8 INCH REBAR AT 25 FEET AND 196.22 FEET.

CONTAINING 1.400 MORE OR LESS ACRES, SUBJECT TO LEGAL ROAD RIGHT-OF-WAY OF TOWNSHIP ROAD 238 (LAWHEAD LAND), AND ALL APPLICABLE EASEMENTS.

IRON PINS SET ARE 5/8 INCH X 30 INCH REBAR WITH PLASTIC IDENTIFICATION CAP.




