

Deed Book 544, Page 482 and Deed Book 2093, Page 805 of the Muskingum County Deed Records bounded and described as follows:

Beginning at an iron pin found at the northeast corner of the southeast quarter of section 3; thence **S 3°30'09"W** (the base of bearings for this description is state plane grid from a solar observation) along the east line of said quarter and the west line of property owned by Larry and Sharron Ball (Vol. 971, Pg. 335) a distance of **584.38** feet to an iron pin set; thence through the lands of said Donald and Janet Staker **S 89°29'05"W** **898.69** feet to an iron pin set; thence **N 3°01'00"E** along the east line of property owned by Hedi Layton (Vol. 1835, Pg. 678) a distance of **639.74** feet to an iron pin found on the north line of said southeast quarter; thence **S 86°34'36"E** along the south line of property owned by Bradley Barker (Vol. 2253, Pg. 198) and the north line of said quarter a distance of **86.97** feet to an iron pin found; thence **S 87°02'46"E** along the north line of said quarter section and the south line of property owned by Joseph and Vicki Farkas (Vol. 2039, Pg. 422) a distance of **122.32** feet to an iron pin found; thence **N 2°31'22"E** and into the northeast quarter of section 3 and along the east line of said Farkas property **1120.80** feet to a three quarter inch pipe found; thence **N 14°28'05"E** along the east line of property owned by Bonnie Paul (Vol. 2379, Pg. 649) **493.11** feet to a point in the center of Dietz Lane and passing through an iron pin found at **459.95** feet; thence **N 63°14'59"E** along the center of said road and along said Paul property **10.00** feet to a point; thence **N 4°31'00"E** along the east line of said Paul property **37.42** feet to an iron pin set; thence **S 64°41'41"E** along Dietz Lane and along the south line of the Hayes Family Tr.(Vol. 1130, Pg.) **100.74** feet to a point **9.00** feet south the centerline of said Dietz Ln; thence **S14°28'05"W** and along the west line of a 4.309 acre parcel owned by Logan C.
