

SURVEY DESCRIPTION

Rose Soller

Part of Auditors Parcel  
73-60-01-27-000 (29.86 Acres)

Situated in the Southwest quarter of section 1, T-11, R-13, Wayne Township, Muskingum County, Ohio. Being part of the lands of Rose Soller conveyed in Deed Book 396 page 349 of the Muskingum County deed records and being described as follows:

Commencing at the Southwest corner of Section 1; thence, N.89°33'39"E. a distance of 1,187.61 feet along South line of section 1 to a found iron pin on the Southeast corner of the lands, now or formerly, owned by R. Deitrick (1849/394); thence, N.00°19'02"W. a distance of 1,438.92 feet along the West line of the lands of R. Soller to a set rebar on the East line of the lands, now or formerly, owned by R. Deitrick (1122/011), BEING THE POINT OF BEGINNING;

Thence, N.00°19'02"W. a distance of 730.40 feet along the East line of said Deitrick lands to a found iron pin on the southwest corner of the lands, now or formerly, owned by C. & S. Deitrick (1141/31);

Thence, S.70°26'42"E. a distance of 1,743.68 feet along said Dietrick lands to a set rebar on the West line of the lands of O.D.N.R. (1140/930);

Thence, S.00°35'25"E. a distance of 1,004.12 feet along the west line of said O.D.N.R. lands, and the lands of D. Mercer, Et Al (1082/029 & 1139/725) to a set rebar on the Northeast corner of the lands, now or formerly, owned by J. Rush (1078/125), said pin is located on the South side of Dietz Lane;

Thence, N.55°02'36"W. a distance of 271.56 feet along said Rush lands to a found iron pin;

Thence, N.00°39'56"W. a distance of 23.76 feet through the lands of R. Soller (396/459) to a point in the center of Dietz Lane;

Thence, N.56°28'59"W. a distance of 329.84 feet along said lane to a found iron pin on the Southeast corner of the lands, now or formerly, owned by C. Riggle (1080/159);

Thence, N.31°40'08"E. a distance of 29.56 feet along said Riggle lands to a found iron pin;

- Thence, **N.40°11'03"W.** a distance of **225.52 feet** along said Riggle lands to a found iron pin;
- Thence, **N.76°52'44"W.** a distance of **158.63 feet** along said Riggle lands to a found iron pin;
- Thence, **S.86°44'08"W.** a distance of **118.43 feet** along said Riggle lands to a found iron pin;
- Thence, **S.43°36'01"W.** a distance of **99.99 feet** along said Riggle lands to a found rail road spike in the center of Dietz Lane;
- Thence, **N.82°05'29"W.** a distance of **162.37 feet** along said lane to a point;
- Thence, **N.79°50'07"W.** a distance of **149.25 feet** along said lane to a point;
- Thence, **N.14°30'08"W.** a distance of **323.83 feet** through the lands of R. Soller (396/459) to a set rebar, passing a set rebar at 16.11';
- Thence, **S.85°56'06"W.** a distance of **291.79 feet** through said Soller lands to The point of beginning, passing a set rebar at 89.16'.

The above described parcel contains **29.86 acres**, more or less, subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.

SURVEY PLAT FOR ROSE M. SOLLER


