Situated in the State of Ohio, County of Muskingum, Township of Wayne, bounded and described as follows:

Being a part of the lands now owned by Dale R. Boyse (OR 1523-555) located in the Northeast Quarter of Section 7 and the Northwest Quarter of Section 8, Township 11 North, Range 13 West, Congress Lands East of the Scioto River, and being more particularly described as follows:

Beginning at the northeast corner of Section 7 of Wayne Township, Township 11 North, Range 13 West;

thence along the north line of Section 8 and the south line of lands now owned by Kevin and Debra Philip (DR 1090-385) South 89 degrees 27 minutes 00 seconds East 280.70 feet to an iron pin set; thence through land now owned by Dale R. Boyse (OR 1523-555) the following three courses:

- 1) South 34 degrees 32 minutes 13 seconds West 1590.83 feet to an iron pin set, passing an iron pin set at 888.75 feet;
- 2) South 52 degrees 42 minutes 24 seconds East 24.68 feet to an iron set;
- 3) South 35 degrees 14 minutes 14 seconds West 236.77 feet to an iron found on the northeast corner of lands now owned by Jeremy M. McLendon and Shannon L. Fitz (OR 1768-245);

thence along said McLendon and Fitz's north line North 55 degrees 28 minutes 26 seconds West 417.25 feet to an iron pin set on said McLendon and Fitz's northwest corner;

thence through said Boyse's lands the following three courses:

- 1) North 30 degrees 59 minutes 22 seconds East 15.50 feet to an iron pin found;
- 2) North 56 degrees 00 minutes 10 seconds West 7.36 feet to an iron pin found;
- 3) North 33 degrees 59 minutes 59 seconds East 1529.01 feet to a stone found on the south line of lands now owned by Chris L. and Marissa K. Smith (DR 1156-983);

thence along said Smith's south line South 89 degrees 59 minutes 28 seconds East 225.11 feet to the principal place of beginning;

containing 16.06 acres, more or less, subject to all legal road right of ways and applicable easements, written or implied.

Bearings are based on the west line as described in Muskingum County Official Record 1523-555 as bearing South 33 degrees 59 minutes 59 seconds West.

Iron pins set are 5/8 inch diameter by 30 inch long rebar with plastic identification caps.


