COMMENCING AT AN EXISTING IRON PIN (AXLE) AT THE NORTHWEST CORNER OF LOT 9 OF CULBERTSON'S SUBDIVISION (PLAT BOOK 1, PAGE 276);

THENCE WITH THE NORTH LINE OF LOT 9, SOUTH 86 DEGREES 00 MINUTES 42 SECONDS EAST 392.67 FEET TO A POINT, SAID POINT BEING THE **PLACE OF BEGINNING** OF THE TRACT HEREIN INTENDED TO BE DESCRIBED, PASSING AN EXISTING IRON PIN (5/8 INCH REBAR) AT 387.83 FEET;

THENCE CONTINUING WITH THE NORTH LINE, SOUTH 86 DEGREES 00 MINUTES 42 SECONDS EAST 216.89 FEET TO A POINT, SAID POINT BEING SOUTH 38 DEGREES 13 MINUTES 10 SECONDS WEST 1.18 FEET FROM AN EXISTING IRON PIN (AXLE);

THENCE LEAVING THE NORTH LINE AND WITH THE WEST LINE OF A TRACT CONVEYED TO W. AND J. EPPLEY (VOLUME 1111, PAGE 496), SOUTH 38 DEGREES 13 MINUTES 10 SECONDS WEST 879.08 FEET TO AN IRON PIN SET;

THENCE LEAVING THE WEST LINE OF SAID EPPLEY TRACT AND TRAVERSING THROUGH A TRACT CONVEYED TO ROBERT L. SHARP (VOLUME 1813, PAGE 125) THE FOLLOWING THREE COURSES AND DISTANCES;

- 1) NORTH 55 DEGREES 12 MINUTES 36 SECONDS WEST 220.22 FEET TO AN IRON PIN SET;
- 2) SOUTH 29 DEGREES 58 MINUTES 46 SECONDS WEST 166.66 FEET TO AN IRON PIN SET;
- 3) SOUTH 33 DEGREES 09 MINUTES 23 SECONDS WEST 225.47 FEET TO A POINT ON THE EAST LINE OF A TRACT CONVEYED TO BETTY ANN SHARP (VOLUME 790, PAGE 279);

THENCE WITH THE EAST LINE OF SAID SHARP TRACT AND FOLLOWING THE APPROXIMATE CENTER LINE OF A CREEK THE FOLLOWING TWO COURSES AND DISTANCES;

- 1) NORTH 12 DEGREES 44 MINUTES 20 SECONDS EAST 224.10 FEET TO A POINT;
- 2) NORTH 62 DEGREES 41 MINUTES 20 SECONDS EAST 54.08 FEET TO A POINT;

THENCE LEAVING THE CENTER OF THE CREEK AND CONTINUING WITH THE EAST LINE OF SAID SHARP TRACT, NORTH 42 DEGREES 40 MINUTES 20 SECONDS EAST 911.00 FEET TO THE **PLACE OF BEGINNING**.




