Being a part of the Northwest Quarter of Section Thirty (30), Township Thirteen (13), Range Twelve (12) of the Congress Lands East of the Scioto River and part of a 6.72 acre parcel owned by Donald and Janet Staker and Recorded in Deed Book 819, Page 64 of the Muskingum County Deed Records bounded and described as follows:

Commencing at an axle found at the Northeast corner of Lot 16 of John Wheeler's First Addition to Duncan Falls (P.B. 7, pg. 30); thence S 2° 42' 38" W (the base of bearings for this description is State Plane Grid from a Solar Observation) and along the west line of said Donald and Janet Staker property (Vol. 819, pg. 64) and along the east line of said John Wheeler's First Addition and the east line of John Wheeler's Second Addition (P.B. 7, pg. 39) a distance of 458.07 feet to a stone found at the east end of Maple Street; thence S 88° 13' 48" E along the north line of property owned by Gladys Janusz (Vol. 549, pg. 567) and the north line of Carol E. Huffman property (Vol. 862, pg. 110) and the south line of property owned by said Donald and Janet Staker a distance of 577.80 feet to an axle found at the true place of beginning for the following described parcel; thence N 14° 00' 02" E 40.03 feet to an iron pin found; thence S 75° 38' 16" E along the south line of property owned by Sonny and Rebecca Kumczyk (Vol. 1106, pg. 637) and Richard and Nancy McLaine (Vol. 535, pg. 144) a distance of 207.08 feet to a 2 inch pipe found on the westerly side of Mound Road; thence S 26° 35' 44" W along the west side of said Mound Road 40.93 feet to an axle found; thence N 75° 38' 47" W along the aforesaid property owned by Carol E. Huffman 198.15 feet to the true place of beginning containing One-hundred-eighty-six thousandths (0.186) of an acre.


