DESCRIPTION OF SURVEY FOR THE ESTATE OF M. JUNE HARTMAN

Situated in the State of Ohio, County of Muskingum, Township of Wayne, Village of Duncan Falls, Section #30, Township #12, Range #13, of the Congress Lands East of the Scioto River;

Being all of the prior deed reference Volume 669, Page 25, of said county's deed records, also being all of Muskingum County Auditor's Parcel Number 73-73-90-04-13-000, and more particularly described as follows:

- Beginning at a 1/2" drill hole (set in a concrete walk) at the Southeast corner Lot #6 of Buckingham's Second Addition to the Village of Duncan Falls as recorded in Deed Book 16, Page 215, also being known as the Southeast corner of the Shroyer and Haines property as recorded in deed reference Volume 66, Page 247;
- #1- thence along the North line of Main Street N 71 37 44 W 32.00 feet to a 1/2" drill hole (set in a concrete walk) at the Southeast corner of a 34.00 foot wide strip exception as described in the prior deed reference Volume 669, Page 25;
 - #2- thence along the East line of said 34.00 foot wide exception N 18 22 16 E 132.00 feet to an iron pin (set) on the South line of a 16.00 foot wide alley as shown on said plat of Buckingham's Second Addition;
 - #3- thence along the South line of said alley S 71 37 44 E 32.00 feet to an iron pin (set) at the intersection of said alley with a second 16.00 wide alley also shown on said plat of Buckingham's Second Addition;
 - #4- thence along the West line of said second alley S 18 22 16 W 132.00 feet to the place of beginning, containing 0.097 acres.

The bearings within this description are based on State Plane Coordinate Grid derived from a Solar Observation (Local Hour Angle Method). Bearings are shown in a format of Degrees, Minutes, & Seconds. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness R.S.6885).






