COMMENCING AT THE NORTHWEST CORNER OF LOT #80 OF SAID TOWN OF PUTNAM, THENCE, SOUTH 00 DEGREES - 00 MINUTES - 00 SECONDS WEST, 313.13 FEET ALONG THE EAST LINE OF MOXAHALA AVENUE TO AN IRON PIN SET, PASSING AN IRON PINS FOUND AT 211.52 FEET AND 245.08 FEET, AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, NORTH 89 DEGREES - 51 MINUTES - 16 SECONDS EAST, 165.03 FEET TO AN IRON PIN SET ON THE WEST LINE OF A 16.5 FOOT ALLEY; THENCE, SOUTH 00 DEGREES - 00 MINUTES - 12 SECONDS EAST, 57.03 FEET TO AN IRON PIN SET; THENCE, SOUTH 89 DEGREES - 51 MINUTES - 16 SECONDS WEST, 165.03 FEET TO AN IRON PIN SET ON THE EAST LINE OF SAID MOXAHALA AVENUE; THENCE, NORTH 00 DEGREES - 00 MINUTES - 00 SECONDS EAST, 57.03 FEET TO THE POINT OF BEGINNING, AND CONTAINING 0.2161 ACRES MORE OR LESS.






