0.169 ACRES

Situated in lot 38 of Buckingham's Terrace in Fair Oaks Addition, City of Zanesville, Muskingum County, Ohio. Being the lands of Pamela Wills, last conveyed in Deed Book 1116 page 248 of the Muskingum County Deed Records and being described as follows:

Commencing at the Southeast corner of lot 38 in Buckingham's Terrace Addition (P.B. 2 Pg. 47); Thence, on a curve to the left an arc distance of 36.30 feet, on a radius of 5,729.58 feet, whose chord bears N.15°03'21"W. a distance of 36.30 feet along west line of Parker Drive to a point, **BEING THE POINT OF BEGINNING**, referenced by a found iron pin which bears N.75°59'12"E. a distance of 0.20 feet;

Thence, **S.75°59'12"W.** a distance of **104.73** feet along the North line of the lands, now or formerly, owned by B. McLendon (729/234) to a found iron pin on the Southeast corner of the lands, now or formerly, owned by C. Young (829/334);

Thence, **N.15°34'44"W.** a distance of **68.21** feet along said Young lands to a found iron pin on the Southwest corner of the lands, now or formerly, owned by W. Gillespie (1145/194);

Thence, **N.73°34'57"E.** a distance of **104.68** feet along the South line of said Gillespie lands to a point on the West line of Parker Drive, referenced by a found iron pin which bears N.73°34'57"E. at 0.35 feet;

Thence, on a curve to the right an arc distance of 72.60 feet, on a radius of 5,729.58 feet, whose chord bears **S.15°35'54"E.** a distance of **72.60** feet along said Drive to the point of beginning.

The above described parcel contains 0.169 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.





