SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, CITY OF ZANESVILLE, AND BEING A PART OF THE FIRST WARD OF THE CITY OF ZANESVILLE, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING, FOR REFERENCE, AT AN IRON PIN FOUND MARKING THE INTERSECTION OF THE NORTH RIGHT-OF-WAY LINE OF HAZLETT COURT (20 FEET WIDE) AND THE SOUTH RIGHT-OF-WAY LINE OF MUSKINGUM AVENUE (66 FEET WIDE) AND BEING THE SOUTHEAST CORNER AND THE PRINCIPLE PLACE OF BEGINNING OF THE TRACT HEREIN TO BE DESCRIBED:

THENCE, CONTINUING WITH THE RIGHT-OF-WAY LINE OF HAZLETT COURT S 55° 13' 36" W 140.00 FEET TO A POINT, PASSING OVER AN IRON PIN FOUND AT 133.53 FEET:

THENCE, CONTINUING WITH SAID RIGHT-OF-WAY LINE S 70° 13' 36" W 132.19 FEET TO AN IRON PIN SET:

THENCE, WITH THE WEST LINE OF THE CENTRAL TRUST PARCEL N 03° 15' 16" W 74.62 FEET TO AN IRON PIN SET:

THENCE, WITH THE SOUTHERLY LINE OF A PARCEL CONVEYED TO THE ADAMS BROTHERS CONTRACTING COMPANY, AS FOUND IN DEED VOLUME 193 PAGE 87 THE FOLLOWING TWO (2) COURSES AND DISTANCES:
