ALL OF AUDITORS PARCEL
81-58-02-19-000 (0.05 Acres)

Situated in the City of Zanesville, Muskingum County, Ohio. Being the lands of Charles and Phyllis Murphy conveyed in deed book 1143 Page 277 of the Muskingum County Deed Records and being described as follows:

Commencing at the Southwest corner of Lot 15 of Silliman's Addition; thence, N.87°00'18"W. a distance of 16.50 along the North line of Silliman Street to a point, BEING THE POINT OF BEGINNING;

Thence, N.87°00'18"W. a distance of 35.68 feet along the North line of said Street to a point on the Southeast corner of the lands, now or formerly, owned by J. Cavanaugh (1056/409), located on the West side of a concrete retainer wall, passing a set rebar at 1.00 and 33.68 feet;

Thence, N.01°55'49"E. a distance of 57.80 feet along said Cavanaugh lands and said retainer to a found iron pin on the Southwest corner of the lands, now or formerly, owned by L. Hamilton (1146/488);

Thence, S.86°39'41"E. a distance of 35.80 feet along the South line of said Hamilton lands to a found iron pin on the West line of Silliman Alley;

Thence, S.02°02'22"W. a distance of 57.58 feet along said alley to the point of beginning.

The above described parcel contains 0.05 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.



