COMMENCING AT THE NORTHWEST CORNER OF LOT #2 OF PATTY TUPPER'S SUBDIVISION, AS RECORDED IN DEED VOLUME 0, PAGE 515, THENCE, NORTH 00 DEGREES - 00 MINUTES - 00 SECONDS EAST, 60.00 FEET TO A POINT AT THE INTERSECTION OF THE NORTH LINE OF SEBORN AVENUE AND THE WEST LINE OF SUPERIOR STREET, SAID POINT ALSO BEING THE SOUTHEAST CORNER OF LOT #43 OF SAID EPPLEY'S UNRECORDED SUBDIVISION; THENCE, NORTH 90 DEGREES - 00 MINUTES - 00 SECONDS WEST, 50.00 FEET ALONG THE NORTH LINE OF SEBORN AVENUE TO AN IRON PIN SET, AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, CONTINUING NORTH 90 DEGREES - 00 MINUTES - 00 SECONDS WEST, 50.00 FEET TO AN IRON PIN SET; THENCE, NORTH 00 DEGREES - 07 MINUTES - 45 SECONDS WEST, 142.00 FEET TO A POINT ON THE SOUTH LINE OF A 16' ALLEY; THENCE, SOUTH 90 DEGREES - 00 MINUTES - 00 SECONDS EAST, 50.00 FEET TO AN IRON PIN SET; THENCE, LEAVING SAID ALLEY, SOUTH 00 DEGREES - 07 MINUTES - 45 SECONDS EAST, 142.00 FEET TO THE POINT OF BEGINNING, AND CONTAINING 0.163 ACRES MORE OR LESS.


