LEGAL DESCRIPTION for Century National Bank

Situated in the State of Ohio, County of Muskingum, City of Zanesville, and being part of Lot 27 of Buckingham and Potwin Addition, as recorded in Plat Book 1, page 218, and being all those lands intended to be described in Deed Reference 1145, page 303; being further bounded and described as follows:

Beginning at an iron pin found at the north corner of said Lot 27, thence, south 25 degrees – 38 minutes – 41 seconds east, 202.73 feet along the west line of Summit Street to an iron pin set;

Thence, north 88 degrees – 04 minutes – 46 seconds west, 95.37 feet to an iron pin set on the east line of Whipple Street;

Thence, north 02 degrees – 24 minutes – 59 seconds east, 179.72 feet along the west line of Lot 27 to the *point of beginning*, and containing 0.197 acres more or less.

Bearings described herein are based on the east line of Whipple Street, as recorded in Plat Book 1, page 218.

Iron pins set are 5/8" rebar with yellow identification cap (Finley S-7222).

All of Auditor's Parcel #83-06-02-01-000.





IRON PINS SET ARE 5/8" REBAR WITH YELLOW I.D. CAP.


LEGEND: IRON PIN SET ●
