Situated in the State of Ohio, County of Muskingum, City of Zanesville:

Being a part of the Southeast Quarter of Section Two (2), Township Sixteen (16), Range Fourteen (14) and known as Lot 22 of a unrecorded plat of Hall's New Addition and the same property now recorded in the name of Martha E. Ball and Willard C. Dodd and Recorded in Deed Book 1128, Page 19 of the Muskingum County Deed Records bounded and described as follows:

Commencing at limestone found at the intersection of the west line of Stewart Street with the north line of Ridge Avenue; thence N 13° 02' 25" W (the base of bearings is State Plane Grid from a Solar Observation) along the west line of Stewart Street 138.20 feet to an iron pin found capped C. R. Harkness No. 6885; thence N 00° 14' 00" E along the west line of said street 57.88 feet to an axle found; thence N 7° 29' 52" E along the west line of said street 204.10 feet to an iron pin set at the southeast corner of Lot 22 and the true place of beginning; thence N 89° 55' 46" W along the south line of said Lot 22 and the north line of property owned by Charles and Barbara Young (Vol. 1146, pg. 427) a distance of 123.24 feet to a 3/4" pipe found; thence N 18° 03' 50" E along the east line of an 14 foot alley and the west line of Lot 22 a distance of 48.18 feet to a 1/2" pipe found; thence S 87° 18' 36" E along the north line of said Lot 22 and the south line of property owned by Randy L. Seevers et al (Vol. 1080, pg. 98) a distance of 113.78 feet to a point on the west line of said Stewart Street and passing through a 3/4" pipe found at 113.46 feet; thence S 7° 29' 52" W along the west of Stewart Street 40.97 feet to the true place of beginning containing One-hundred-eighteen-thousandths (0.118) of an acre.

All iron pins set are 5/8" x 30" rebar capped Graves No. 5792.




SURVEYORS NOTE:

THE LINES OF OCCUPATION WORK NORTHERLY PINS BUT SHORTEN DISTANCE ON WEST LINE OF LOT 20. THE SOUTHERLY WOULD BE CLOSE TO ONE HOUSE AND ON THE CORNER OF THE SECOND HOUSE. THIS SURVEY USED THE PINS THAT WORKED WITH THE LINES OF OCCUPATION


