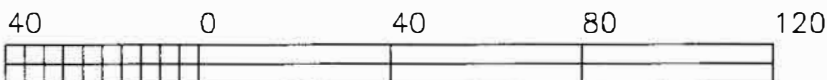

SURVEYOR'S NOTES & REFERENCES:

Note #1 - No original monuments were found and not proration of lots were applied. Long term occupation within the block aligns with the lot layout as shown, including sidewalk splits, old fence lines, buildings, and curbs.

Note #2 - More recent occupation on Lots #12 and #13 are in general agreement with the survey of Lot #12 completed by Alan Donaker PLS #8050 dated April 2002. An apparent survey establishing the NE corner of Lot #16 matches curb splits for Luck Avenue.

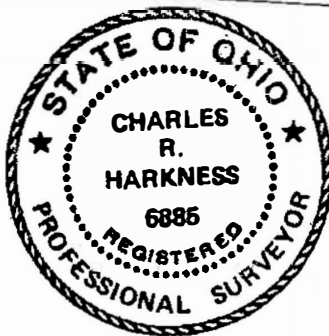
