Commencing at an iron pin found at the Southeast corner of Lot 18 of Sullivan's Second Addition, Plat Book 1, page 29; Thence the next three courses and distances to the place of beginning – North 70°03'10" West 53.41 feet to an axle found, North 69°45'50" West 159.26 feet to an iron pin found, and South 19°30'10" West 64.64 feet to an axle found the place of beginning; Thence South 19°14'02" West along a 16.50 foot wide alley 139.50 feet to an iron pin set; Thence North 70°45'00" West along a 16.50 foot wide alley 82.50 feet to an iron pin set; Thence South 19°16'00" West 8.25 feet to the center of an abandoned alley; Thence North 55°45'27" West along the center of abandoned alley 113.92 feet to an iron pin set; Thence North 40°55'20" East along Mean High Water Line of Licking River 127.28 feet to a point; Thence South 70°45'00" East along Ronald and Mildred Hall Deed Volume 852, page 275, 145.50 feet to the place of beginning passing an axle found at 15.88 feet containing 0.536 Acres more or less, Parcel No. 83-29-01-01-000. ✓

Commencing at an iron pin found at the Southeast corner of Lot 18 of Sullivan's Second Addition recorded in Plat Book 1, page 29; Thence, on the next five courses and distances to the place of beginning – North 70°03'10" West 53.41 feet to an axle found, North 69°45'50" West 159.26 feet to an iron pin found, South 19°30'10" West 204.14 feet to an iron pin set, North 70°45'00" West 82.50 feet and South 19°16'00" West 8.25 feet to a point the place of beginning; Thence South 19°16'00" West along a 16.50 foot wide alley 140.25 feet to an iron pin set on the North line of West Main Street; Thence North 70°45'00" West along West Main Street 110.00 feet to a point from which an axle found bears South 19°15'00" West 5.16 feet; Thence North 19°15'00" East along G&M Construction Deed Volume 942, page 11, 169.72 feet to an iron pin set in the center of an abandoned 16.50 foot wide alley; Thence South 55°45'27" East along the center of said alley

113.92 feet to the place of beginning containing 0.391 Acres more or less,
0.162 Acres in Parcel No. 83-26-01-01-000, 0.229 Acres in Parcel No. 83-
26-01-02-000. — 1241 MAIN ST

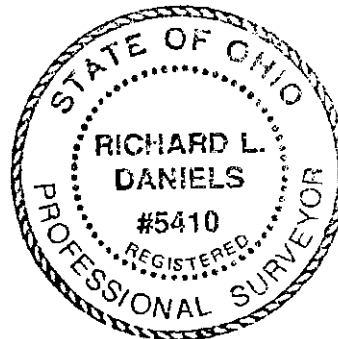

Iron pins set are No. 5 reinforced bars 30 inches long with plastic ID caps.

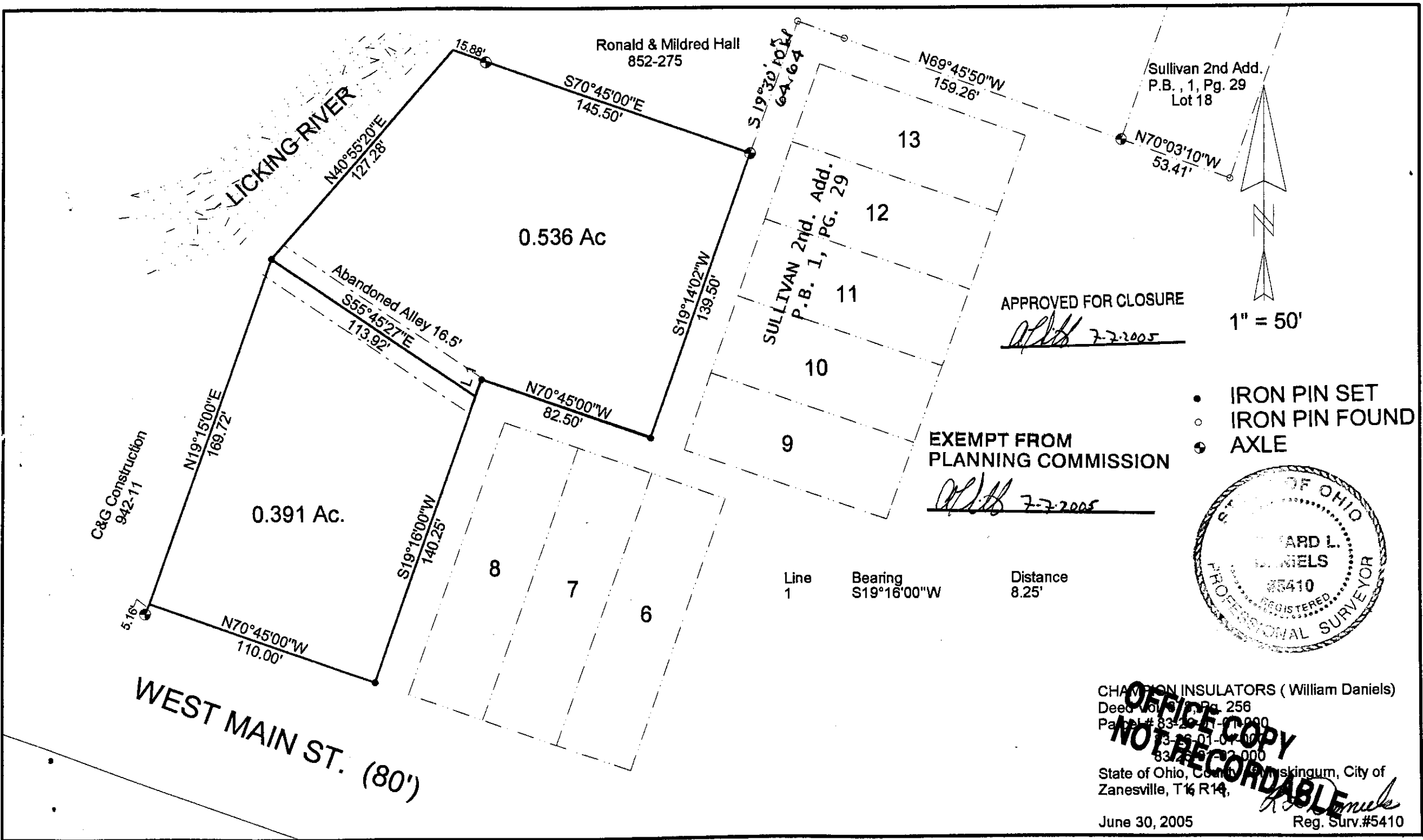

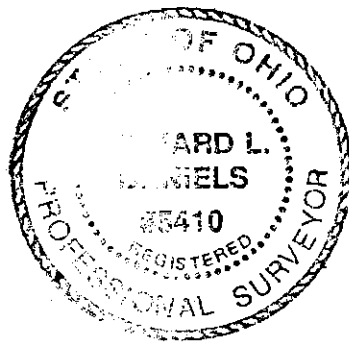
