

PLAT OF ALLEY VACATION

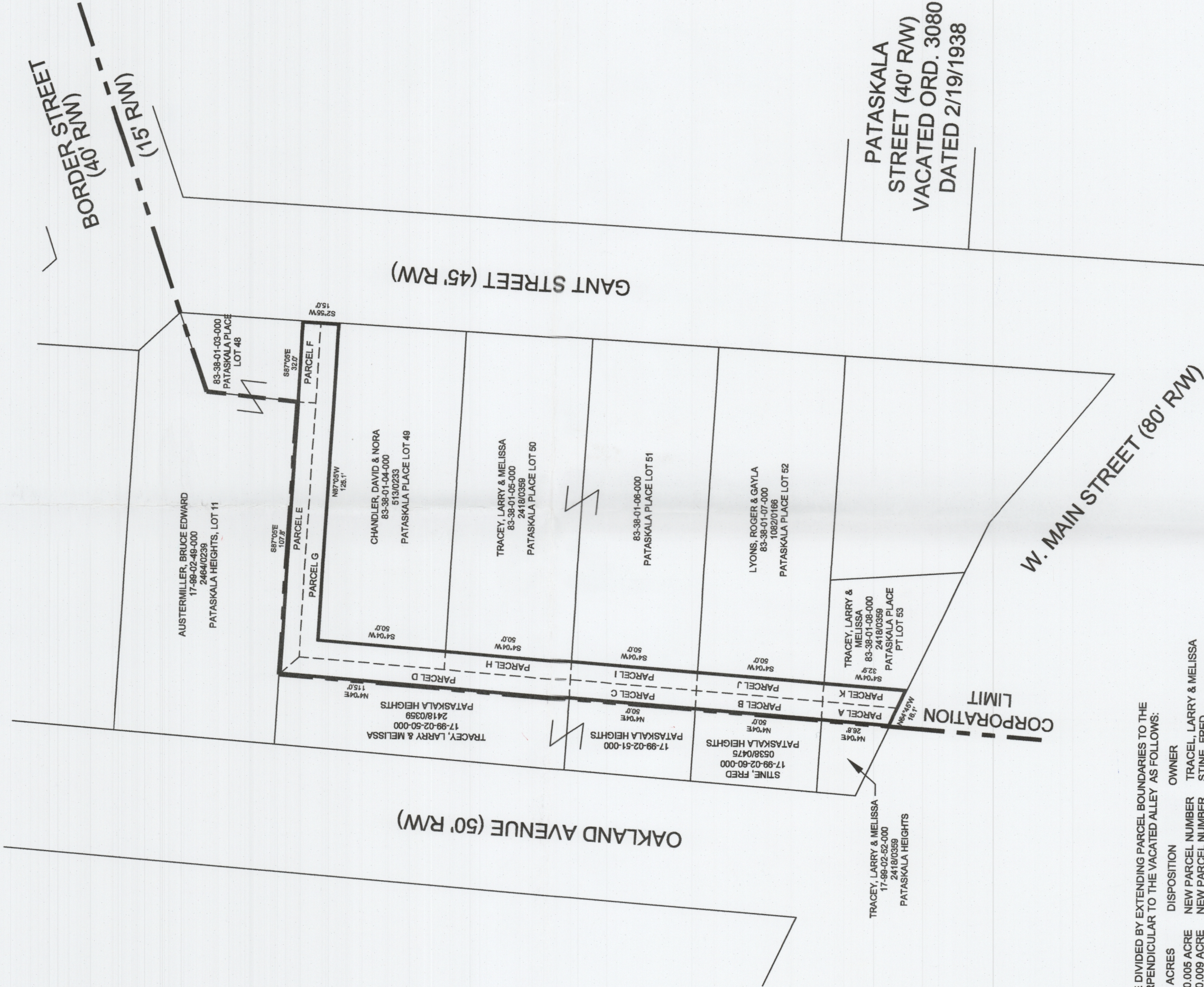
SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM,
