

Situated in the State of Ohio, County of Muskingum, City of Zanesville:

Being part of Lot 5 of Turner's Subdivision recorded in Re-Plat Book 1, Page 194, further being all of the Juanita Norris property recorded in Deed Book Volume 673, Page 302, of said county's deed records, further being all of Muskingum County Auditor's Parcel Number 83-42-03-21-000, and more particularly described as follows;

- Beginning at an iron pin (set) at the common corner for Lots 4 and 5 of said Turner's Subdivision, also being on the North line of Keen Street;
- #1- **THENCE North 61 degrees 29 minutes 40 seconds West 30.00 feet** along Lot 5 and Keen Street to an iron pin (set) at the common corner for said Norris property and for the City of Zanesville property recorded in Deed Book Volume 843, Page 29;
 - #2- **THENCE North 28 degrees 08 minutes 05 seconds East 120.75 feet** crossing said Lot 5 and along the common line for said Norris and City properties to an iron pin (set) on the North line of Lot 5, also being the South line of a 16 foot wide alley;
 - #3- **THENCE South 61 degrees 29 minutes 40 seconds East 30.00 feet** along Lot 5 and alley to an iron pin (set) at a common corner for said Lots 4 and 5;
 - #4- **THENCE South 28 degrees 08 minutes 05 seconds West 120.75 feet** along said Lots 4 and 5 to the place of beginning, **containing 0.083 acres.**

The bearings within this description are based on State Plane Coordinate Grid (Ohio South 1983) derived from GPS Observations. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).

This description was written by Charles R. 





streets alleys and the plat of West Zanesville.


Note #2- Long time occupation, street and alley

foot deep lots with a 16 foot wide alley. These
dimensions fit existing curbs, between Turner
and Keen Street and were used in this survey.
