Being a parcel of land owned by MARY KATHRYN HOSEY, parcel # 80-86-30-01-27-000, recorded in volume 844, page 358, located in the State of Ohio, Muskingum County, City of Zanesville, being part of the east half of Quarter Township 1, Township 1, Range 8 of the United States Military Land and bounded and described as follows:

Commencing at an axle at the southwest corner of lot #80, Northgate Subdivision #3, said point being in the north line of Pfeifer Drive, thence with the north line of Pfeifer Drive, South 87 deg. 00 min. 00 sec. East, 90.00 feet to an iron bar found at the southeast corner of lot #80, thence South 87 deg. 00 min. 00 sec. East, 141.13 feet to an iron pin found at the southwest corner of the parcel herein described, said point being the true place of beginning;

thence from this true place of beginning, along the east line of Fairway Lane, North 27 deg. 13 min. 06 sec. East, 120.51 feet to an iron pin set, at the southwest corner of a 1.33 acre parcel of land conveyed to Trinity Evangelical Lutheran Church of Zanesville, in volume 501, page 503;

thence along the south line of said 1.33 acre church parcel, South 87 deg. 02 min. 18 sec. East, 80.00 feet to an axle found at the northwest corner of a 0.25 acre parcel of land also conveyed to Trinity Evangelical Lutheran Church of Zanesville, in volume 442, page 712;

thence with the west line of said 0.25 acre church parcel, South 03 deg. 00 min. 47 sec. West, 109.96 feet to a iron pin set;

thence with the north line of Pfeifer Drive, North 87 deg. 00 min. 00 sec. West, 129.41 feet to the true place of beginning and containing 0.26 acres, more or less.

Iron pins set are one 5/8 inch rebar, 30 inches long with yellow ID cap stamped DADECO #56345;




