Situated in the County of Muskingum, in the State of Ohio, and in the Township of Falls, and bounded and described as follows:

Being 59.64 feet off the North side of Lot No. 34 and 8.36 feet off the South side of Lot No. 35 of RIDGEWOOD NUMBER TWO as recorded in Plat Book 7, Page 28 of the Records of said county, said premises being known as 2727 West Ridgewood Circle, Zanesville, Ohio, and more particularly described as follows:


Commencing, for reference, at the Southeast corner of said Lot No. 34; thence run North 01 degree 43 minutes 38 seconds East along the east line of said lot a distance of 10.02 feet to the True Place of Beginning of the premises herein intended to be conveyed; thence continuing North 01 degree 43 minutes 38 seconds East along the east line of said lot a distance of 59.75 feet to the Northeast corner thereof; thence North 00 degrees 34 minutes 11 seconds West along the east line of said Lot No. 35 a distance of 8.40 feet to a point; thence North 84 degrees 51 minutes 00 seconds West and parallel with the south line of Lot No. 35 a distance of 133.91 feet to a point on the west line thereof; thence South 01 degree 41 minutes 00 seconds East along the west line of Lots Nos. 35 and 34, passing the Southwest corner of Lot No. 35 at 8.42 feet, a total distance of 68.49 feet to a point on the west line of Lot No. 34 from which the Southwest corner of Lot No. 34 bears South 01 degree 41 minutes 00 seconds East 10.07 feet; thence South 84 degrees 51 minutes 00 seconds East 130.17 feet to the True Place of Beginning, containing 0.2064 acre.

0.1807 acre of the above described tract lies in Lot No. 34 and 0.0257 acre lies in Lot No. 35.
