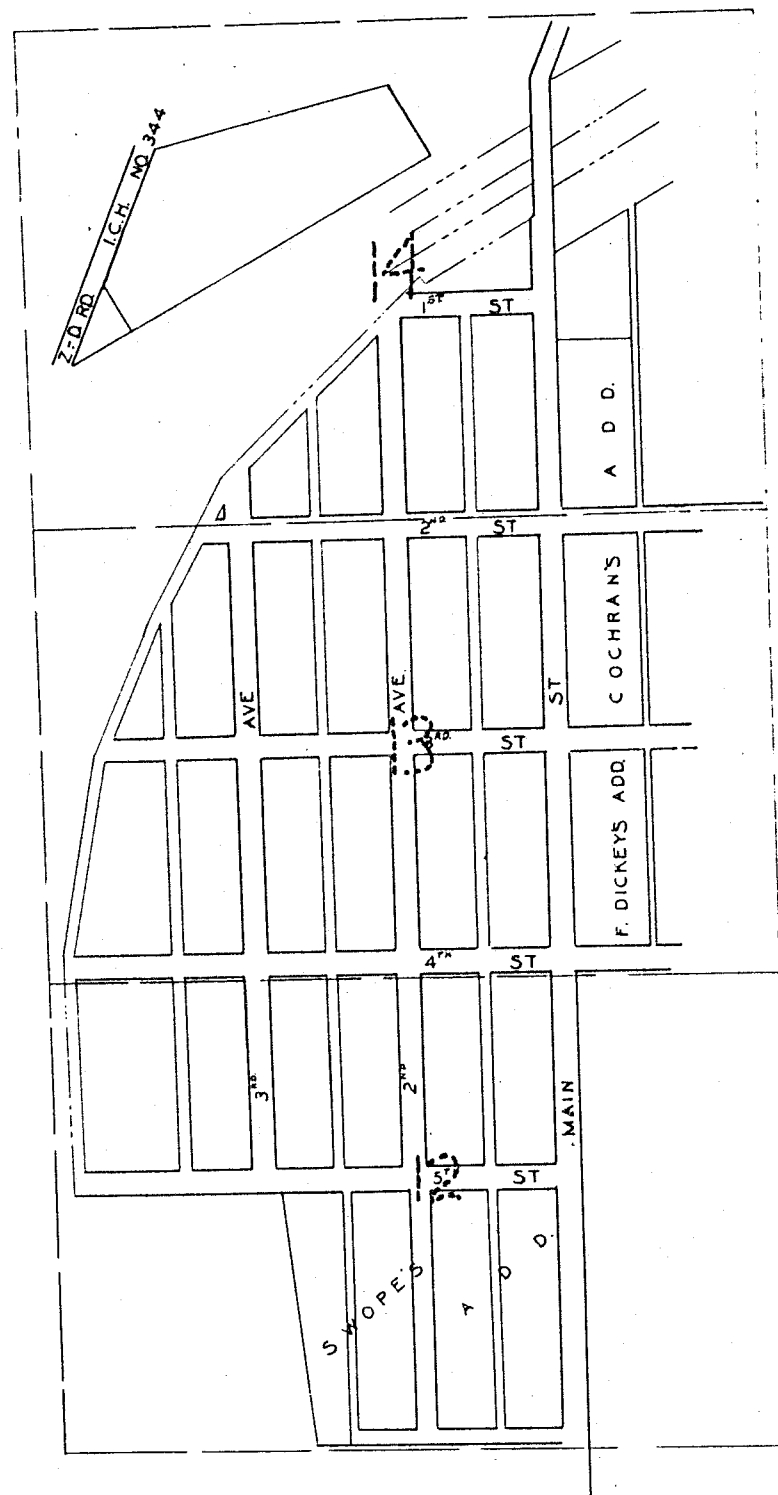
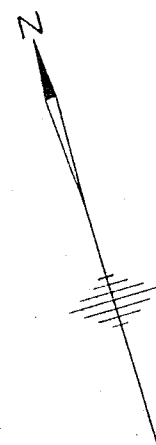
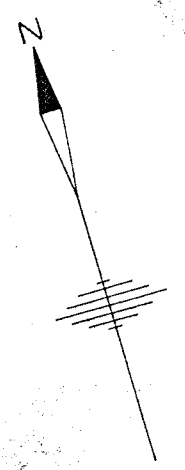
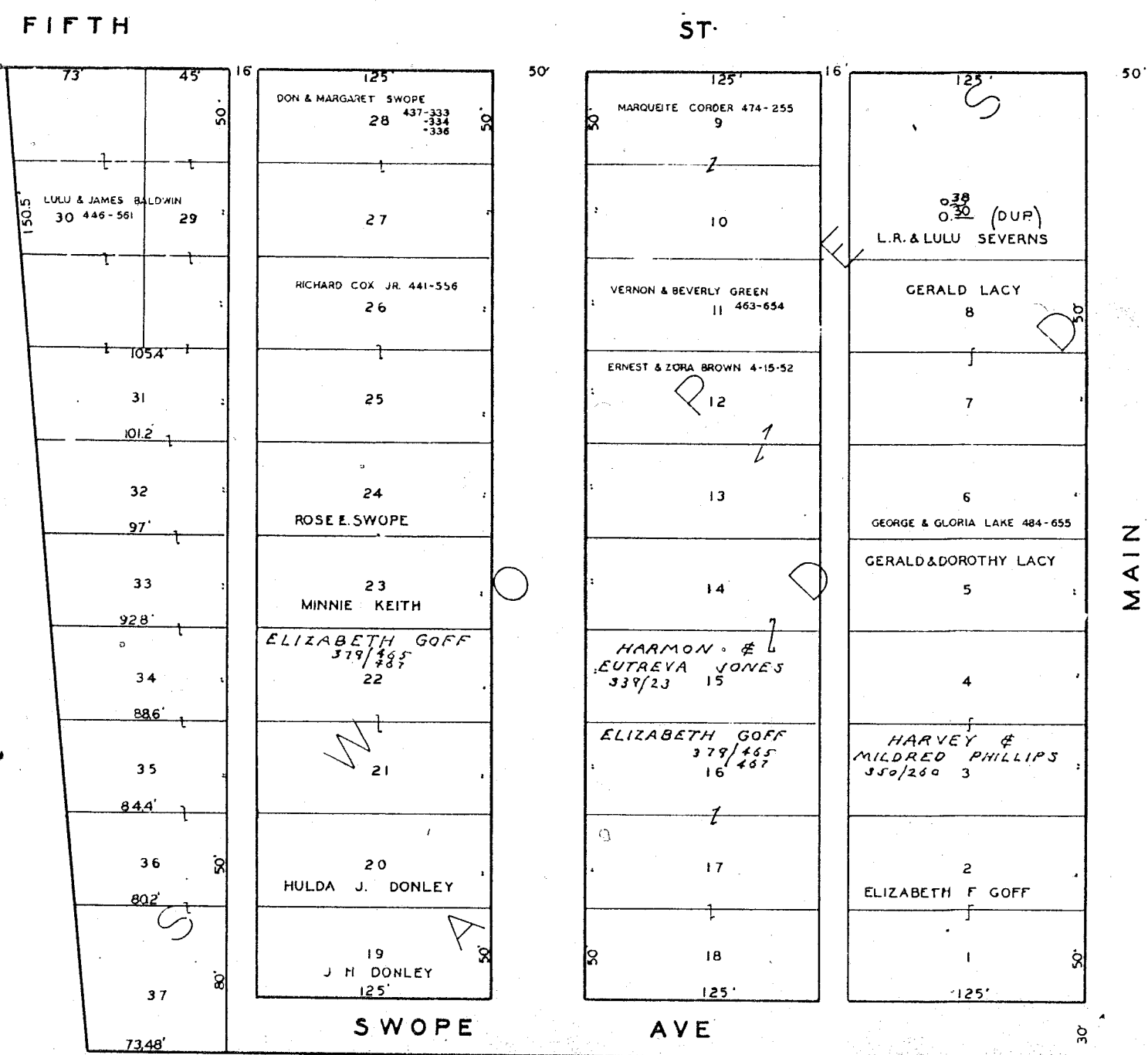
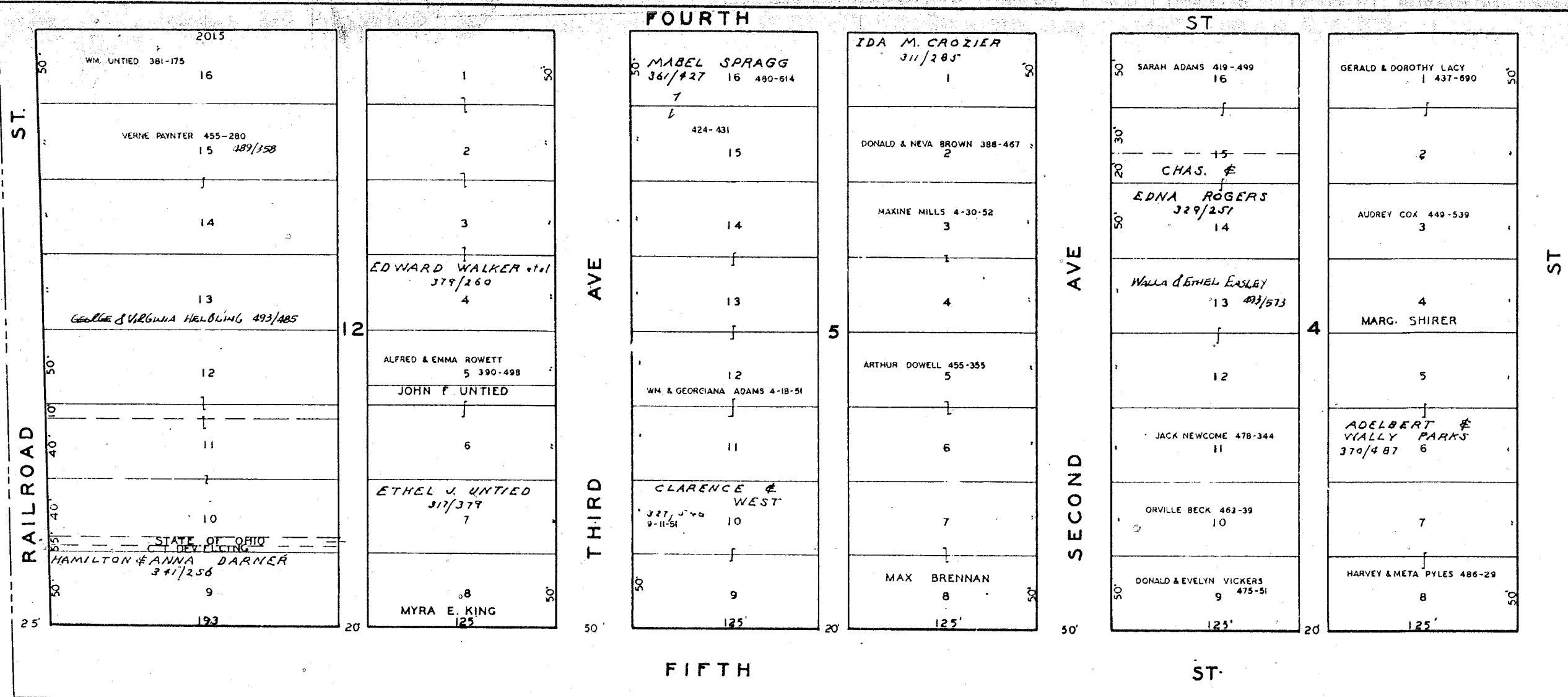


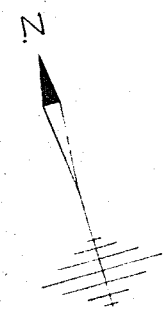


KEY MAP

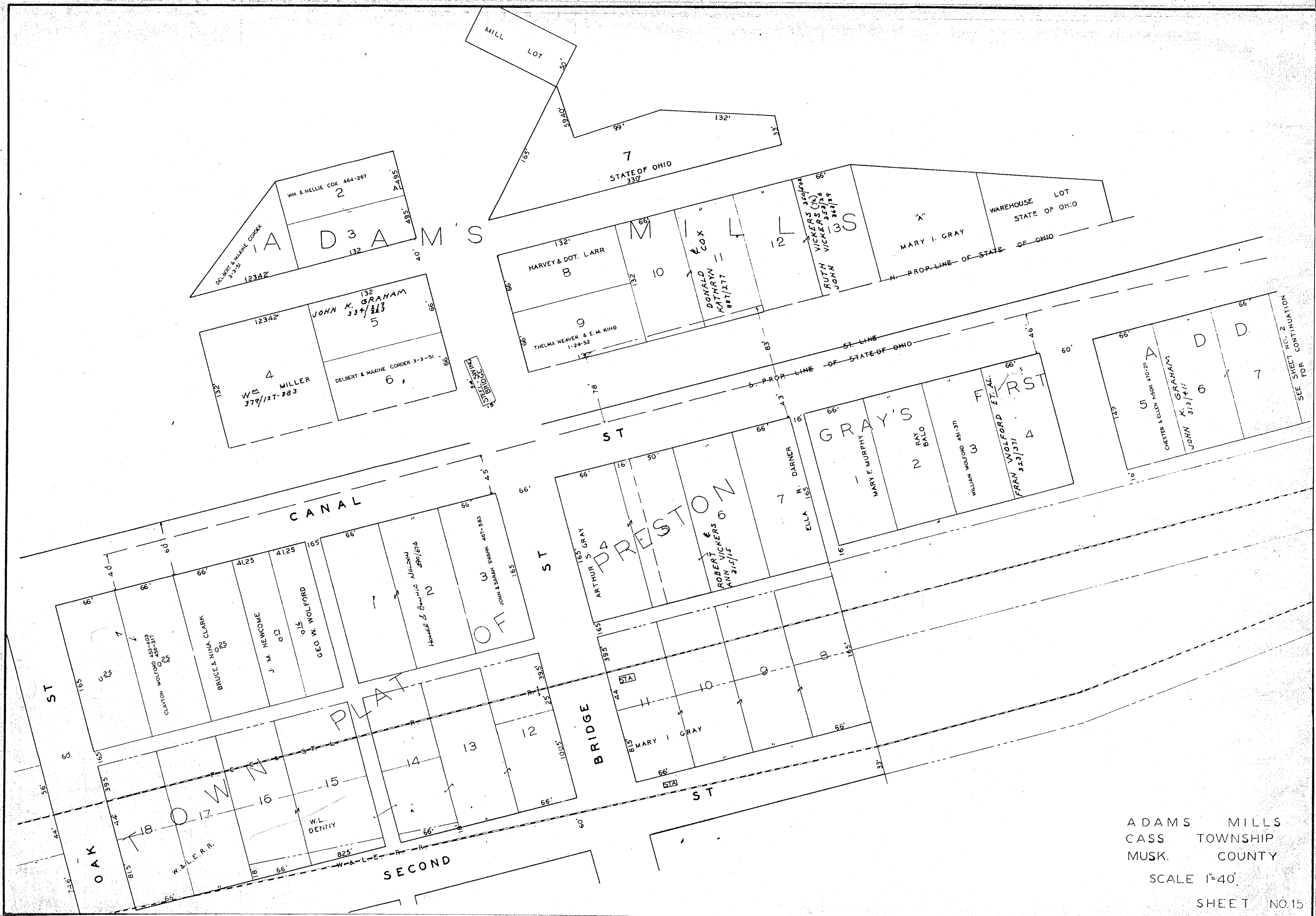

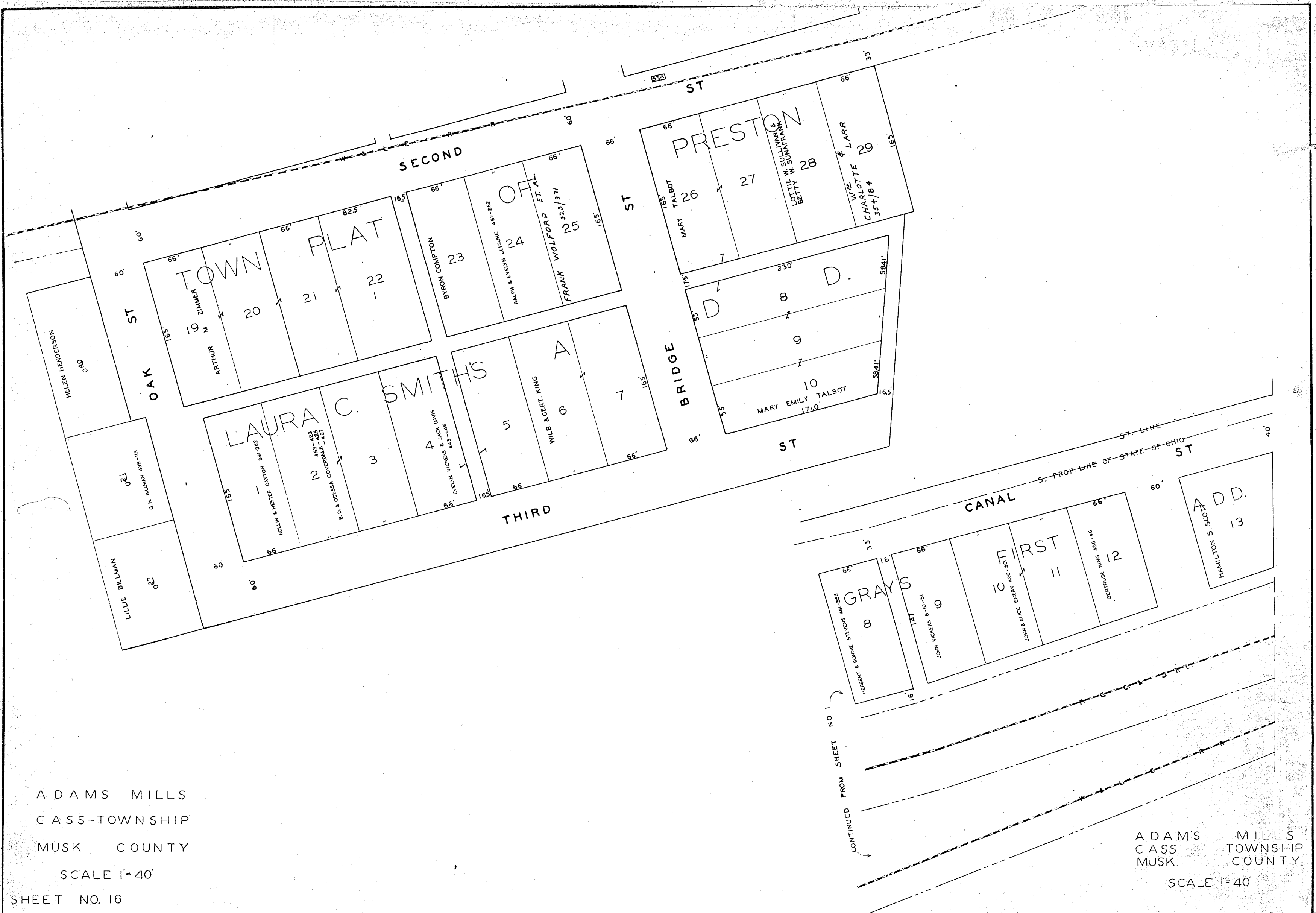

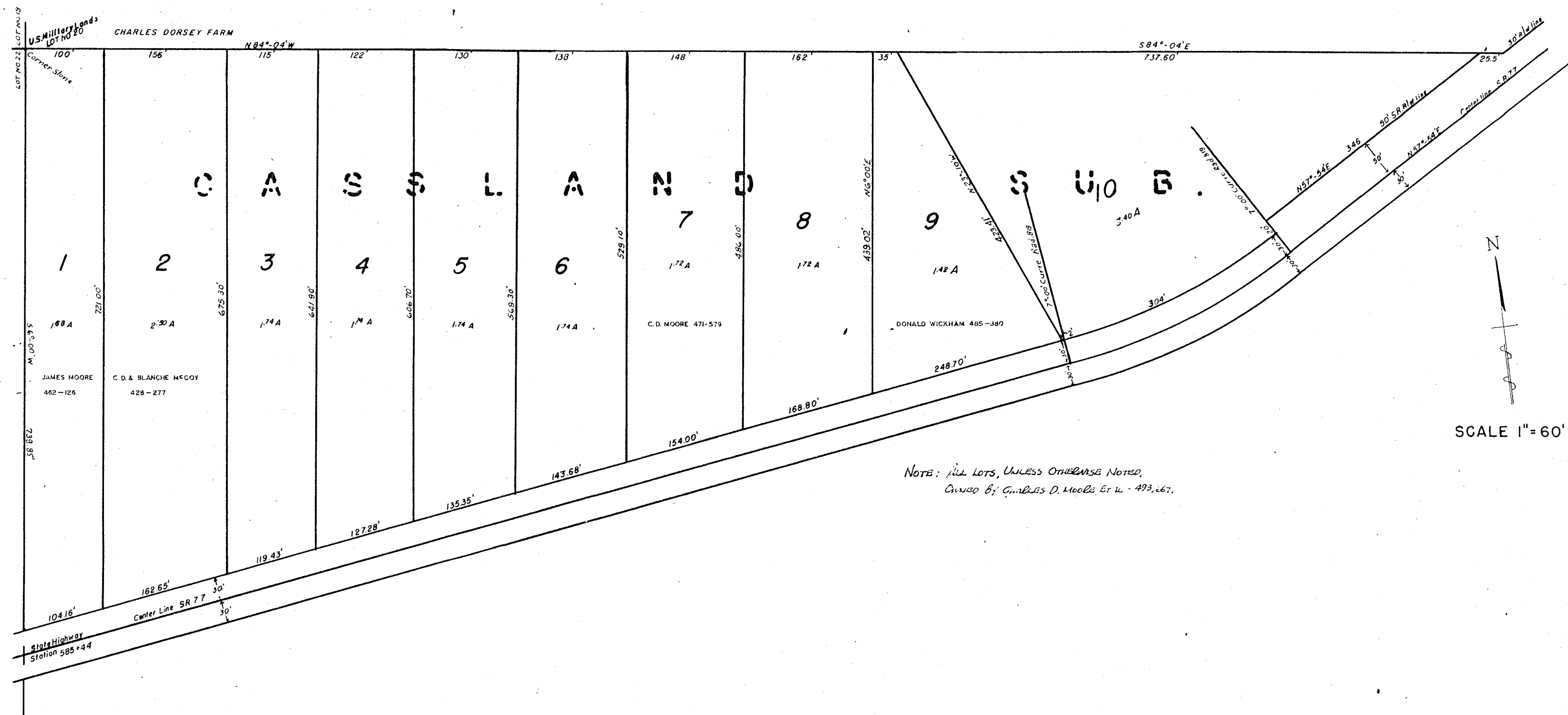
