

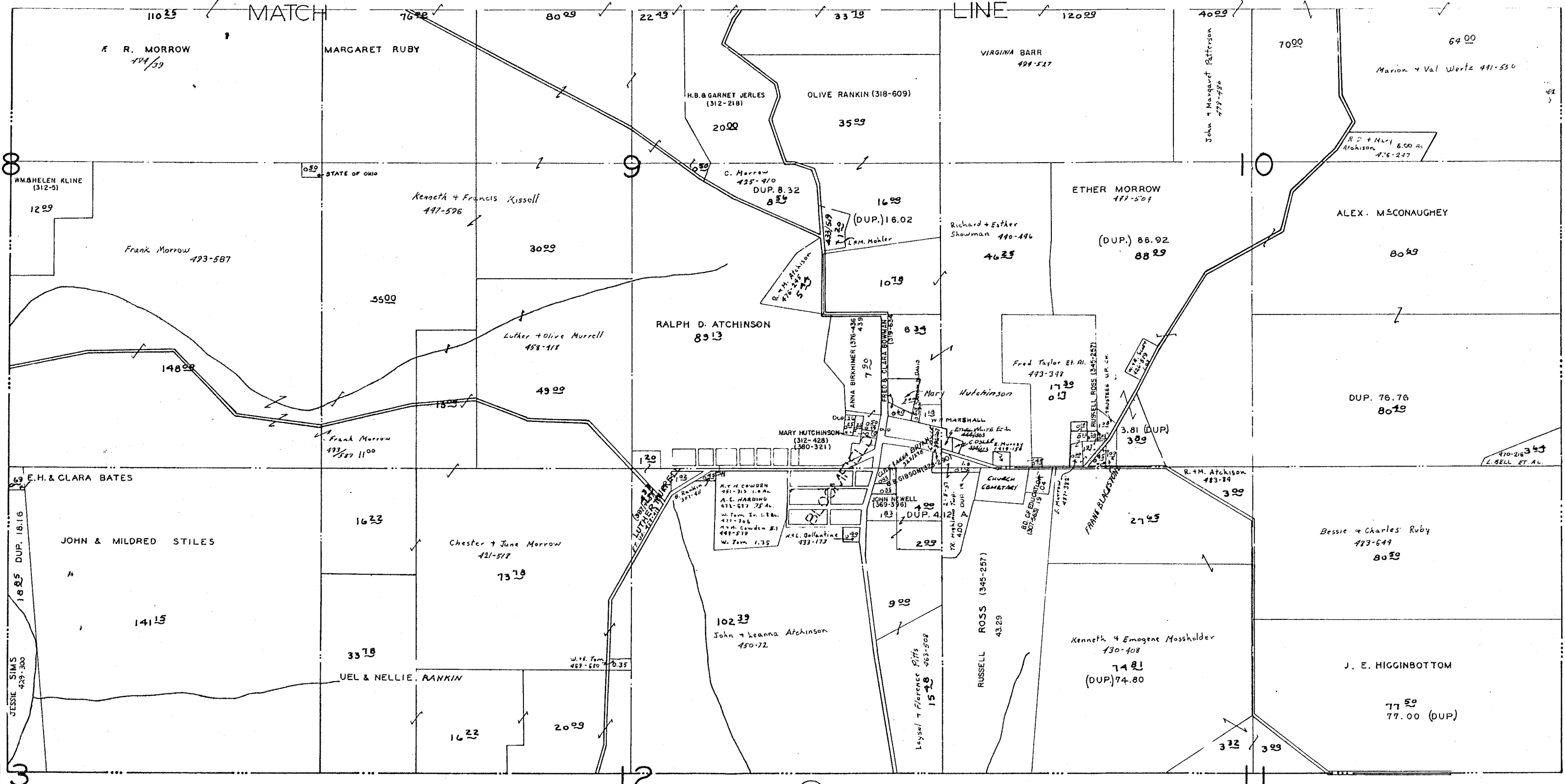
KEY MAP

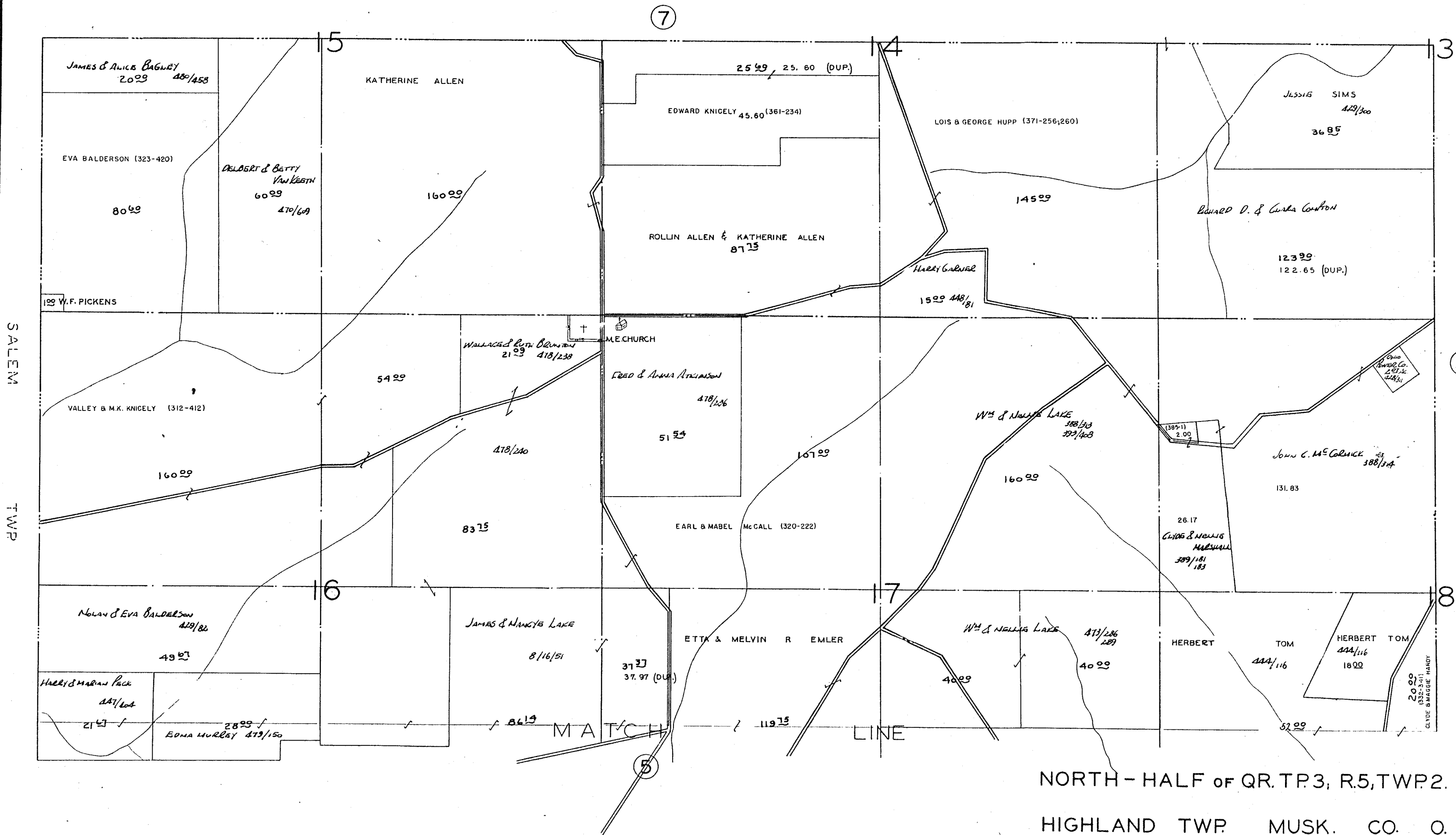

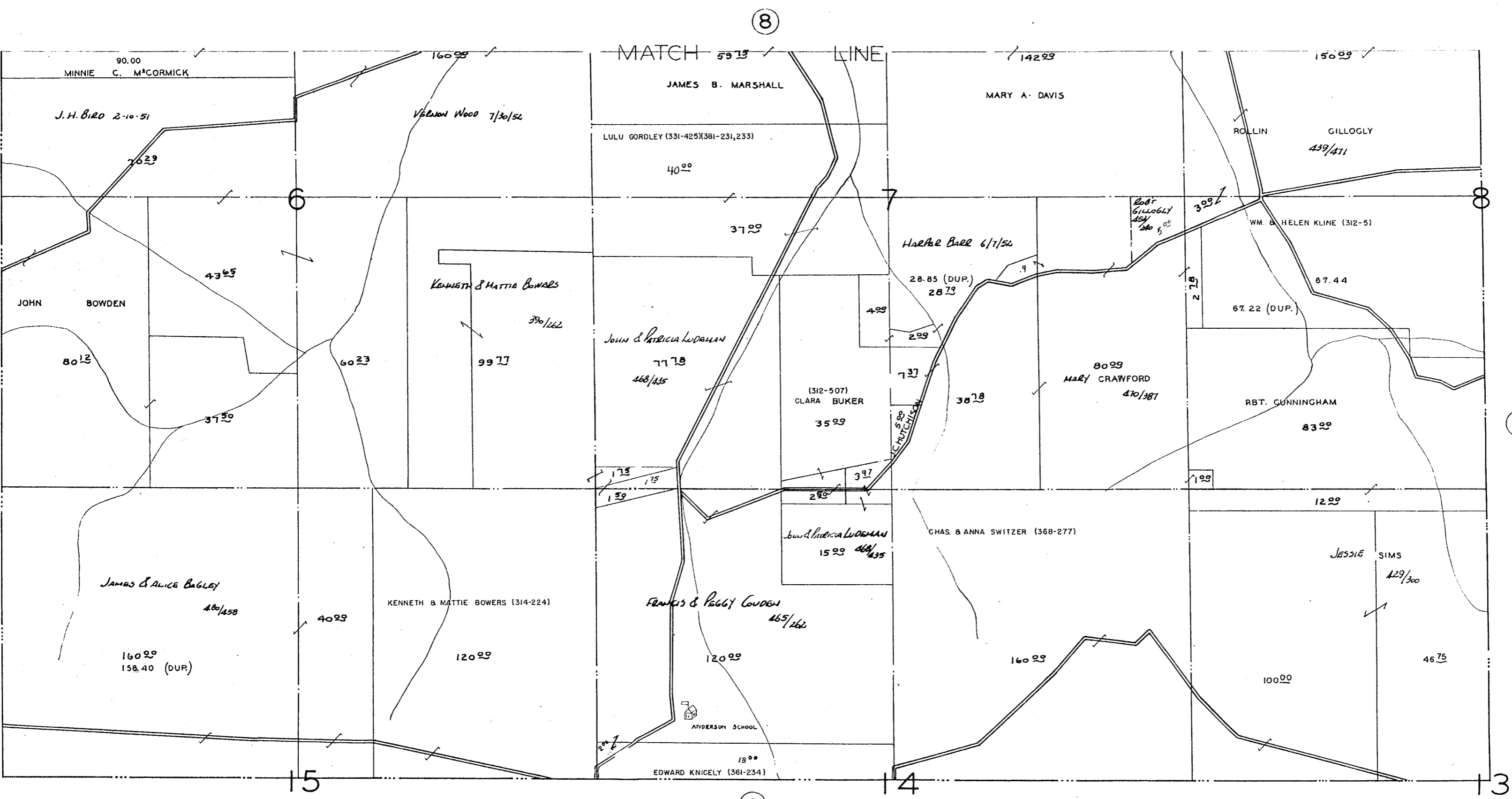
NORTH - HALF of QR. TP.3, R.5, TWP.2.

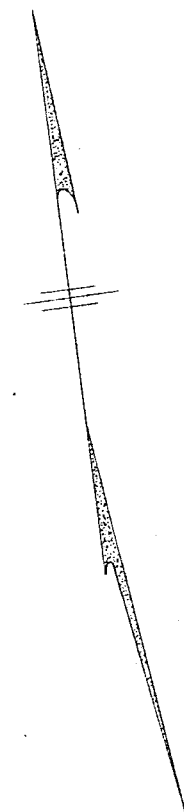
