

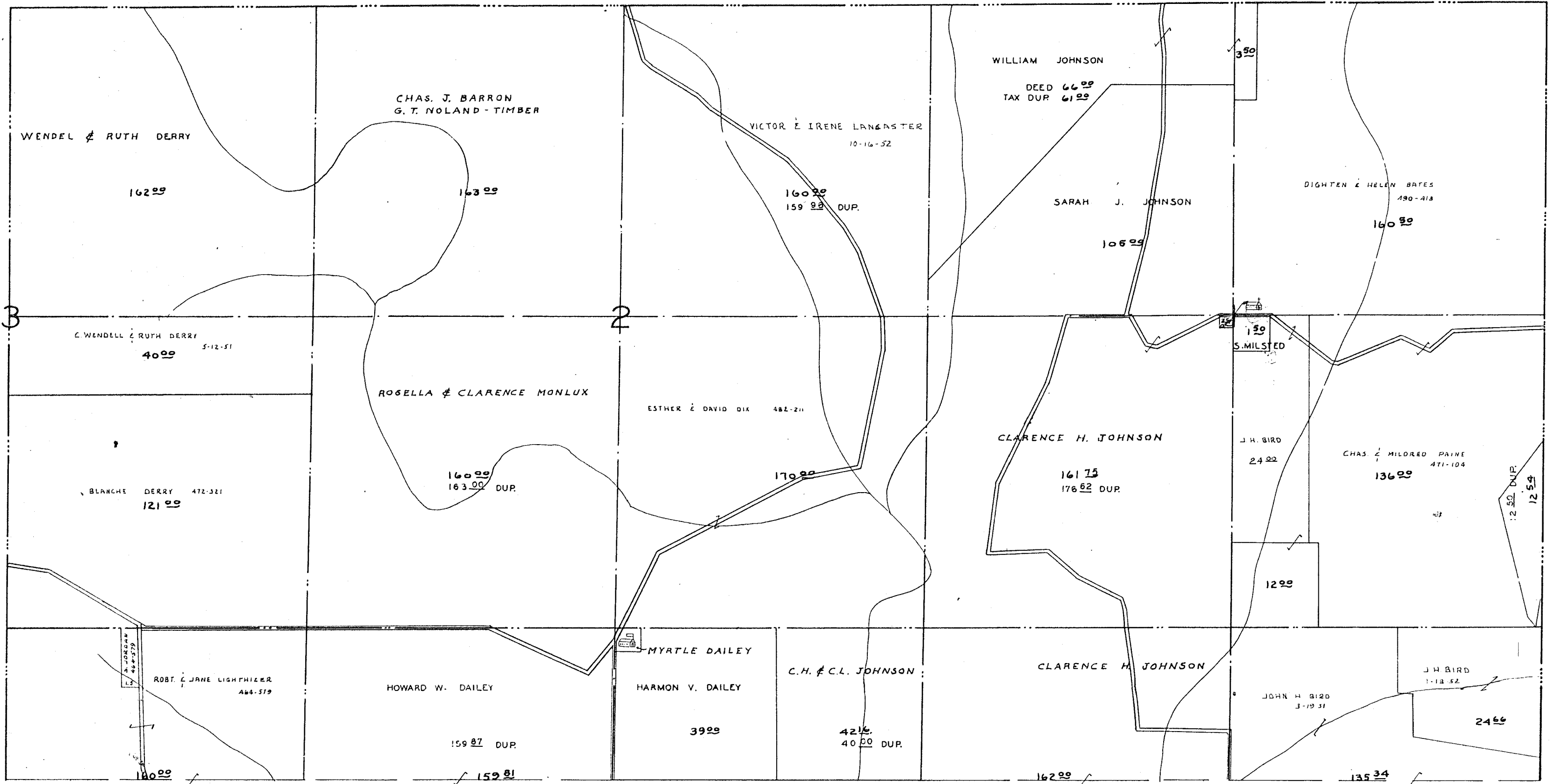
KEY MAP

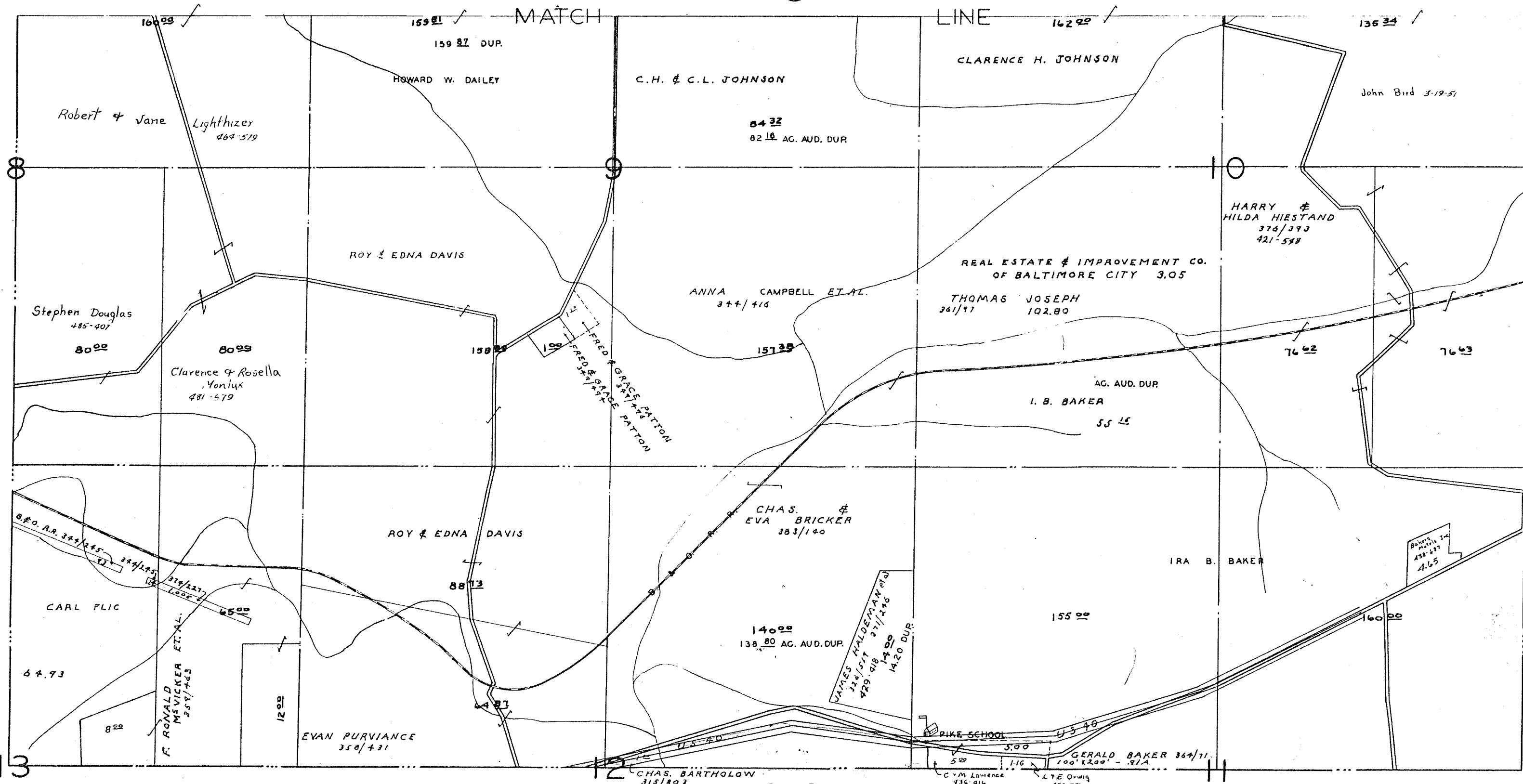

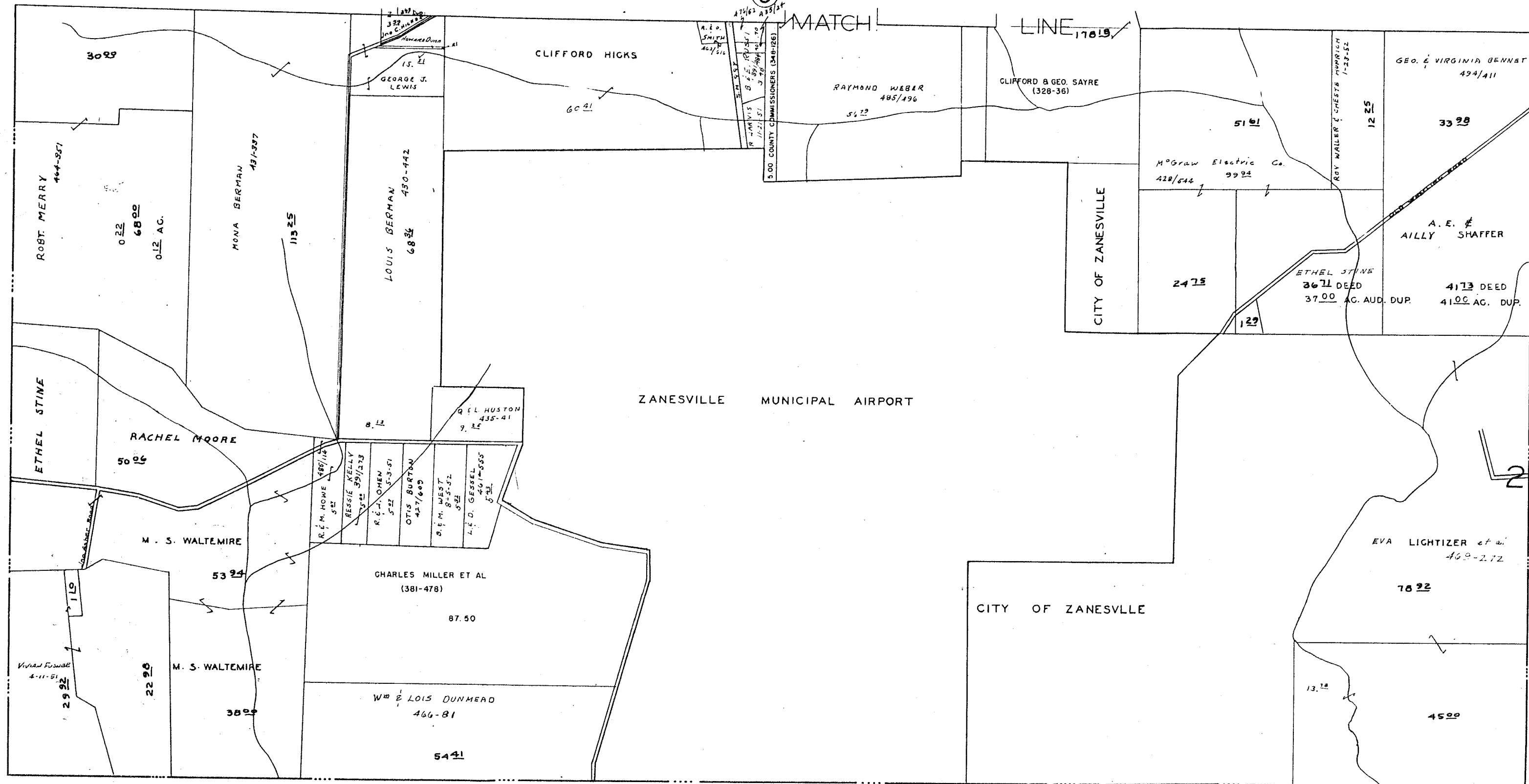
SOUTH-HALF OF QR. T.P. 4, R. 6; TWP. 1.

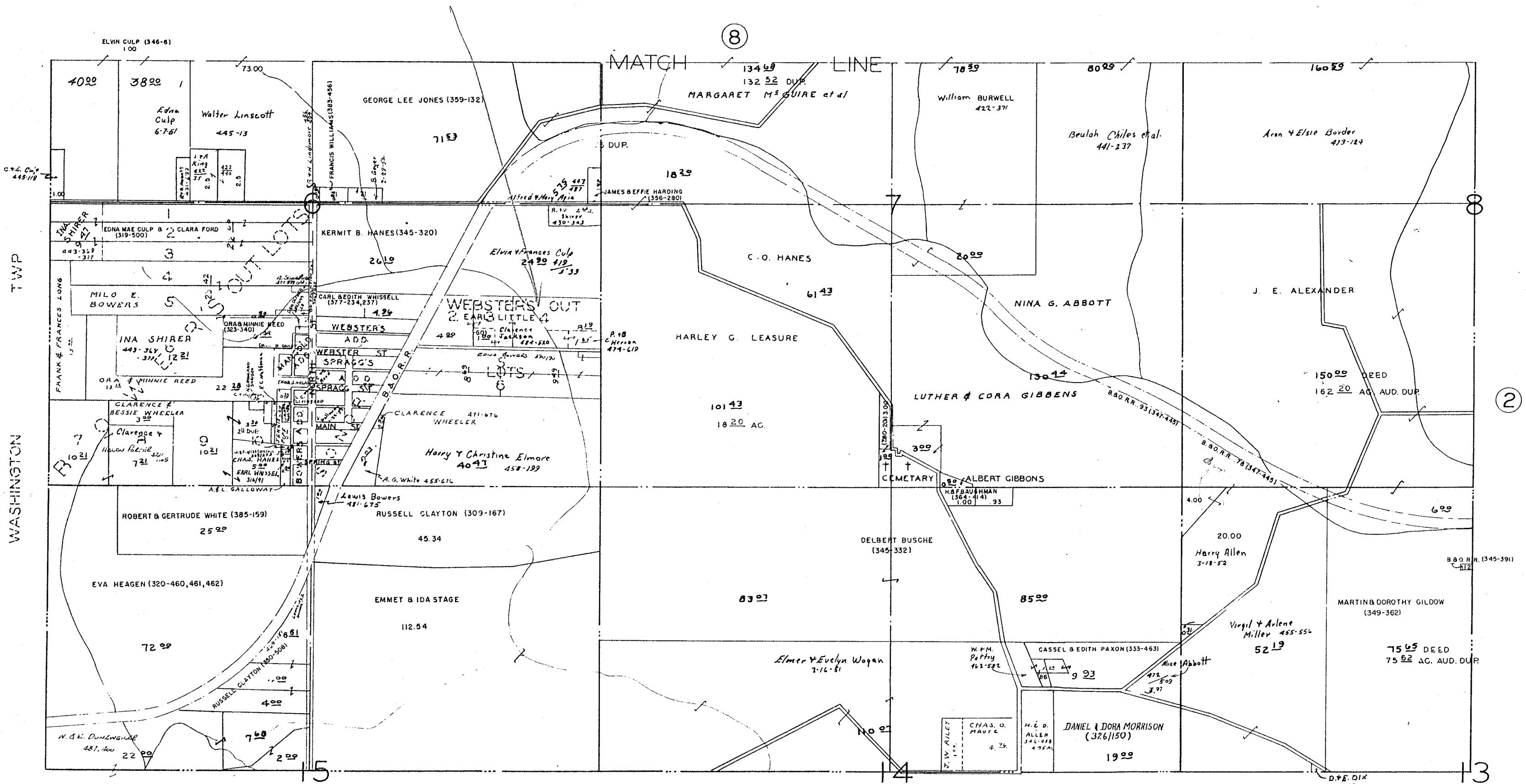

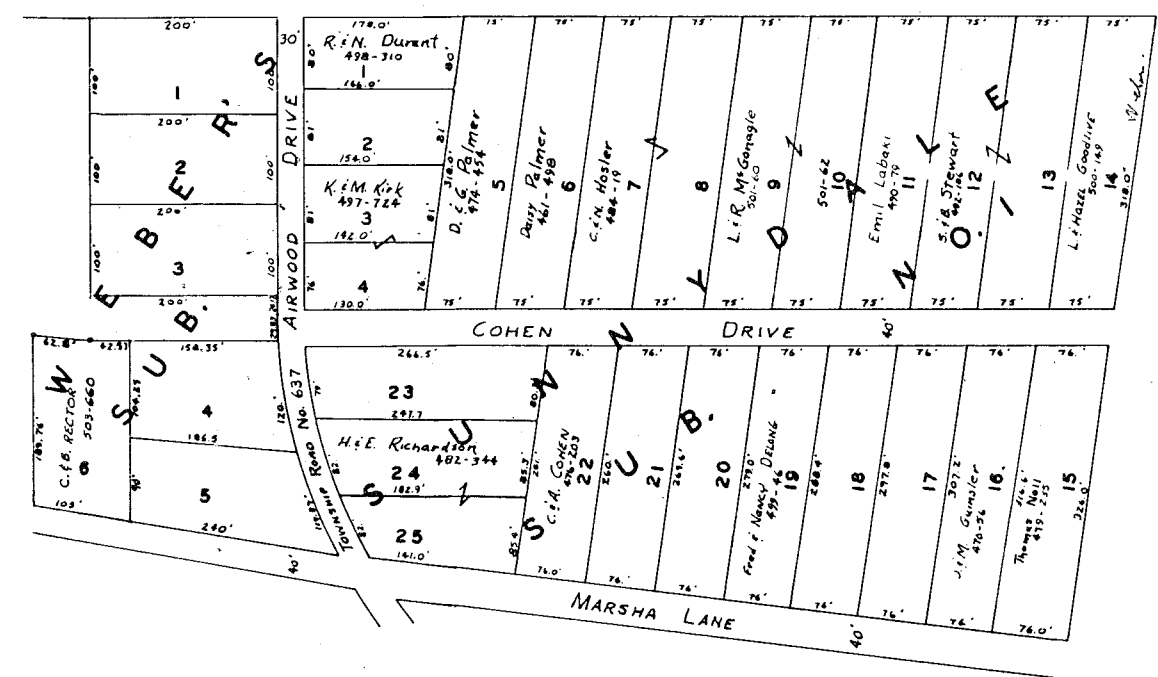
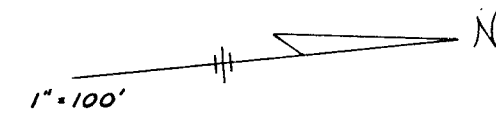


AIRWOOD SUB. No. 2
Part 3rd Qtr., Twp. 1, Rn. 6, U.S.M.L.

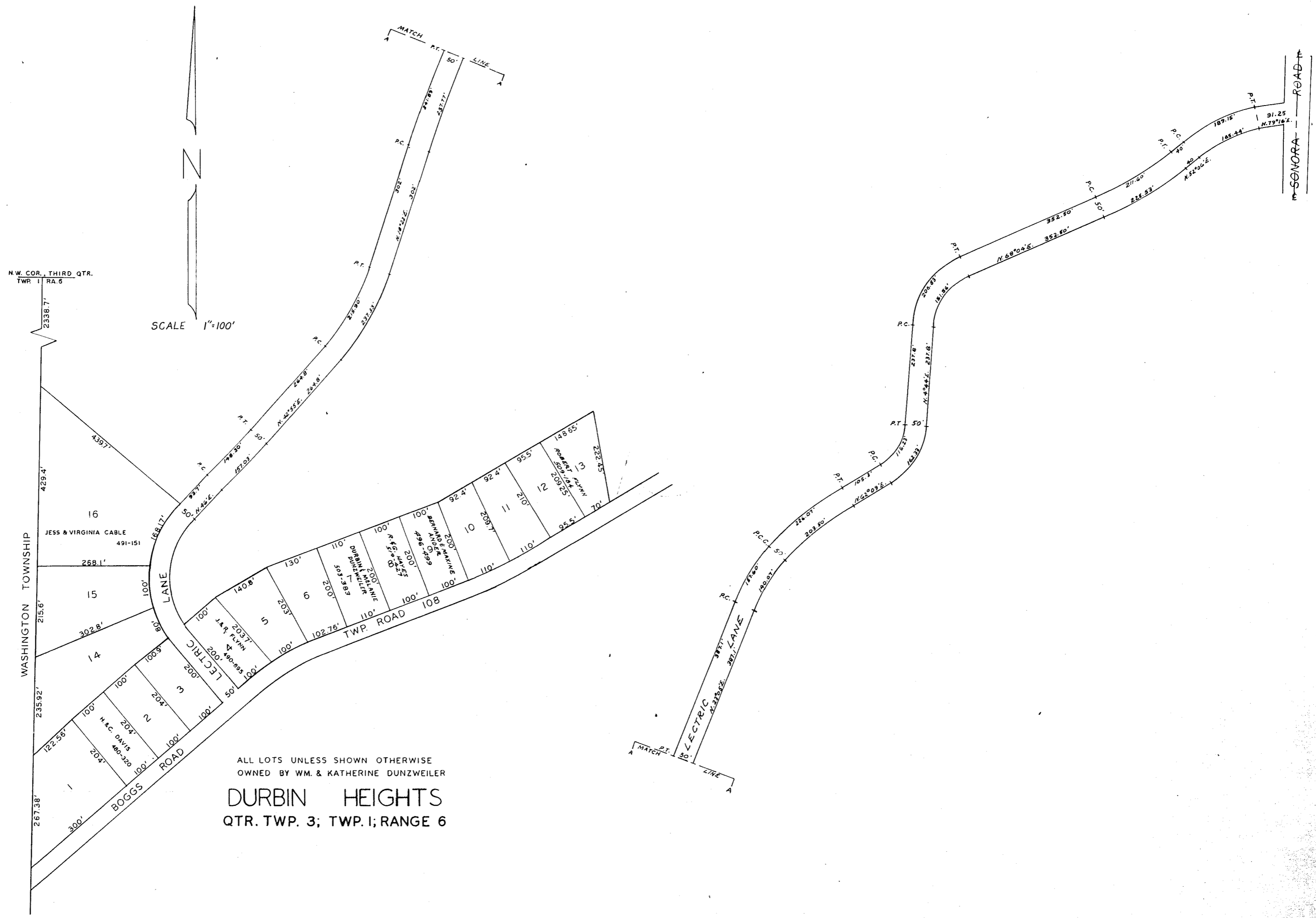

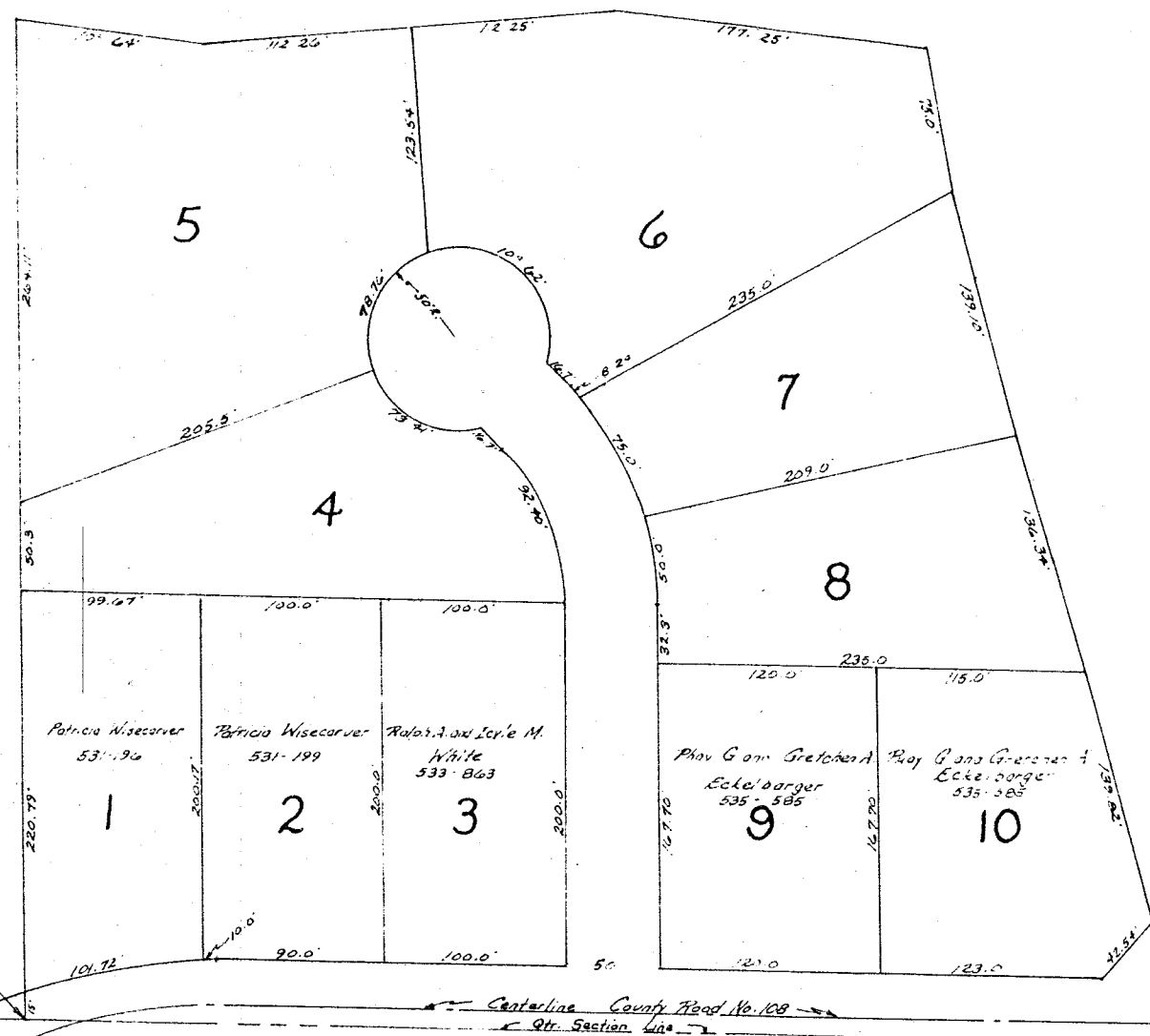
