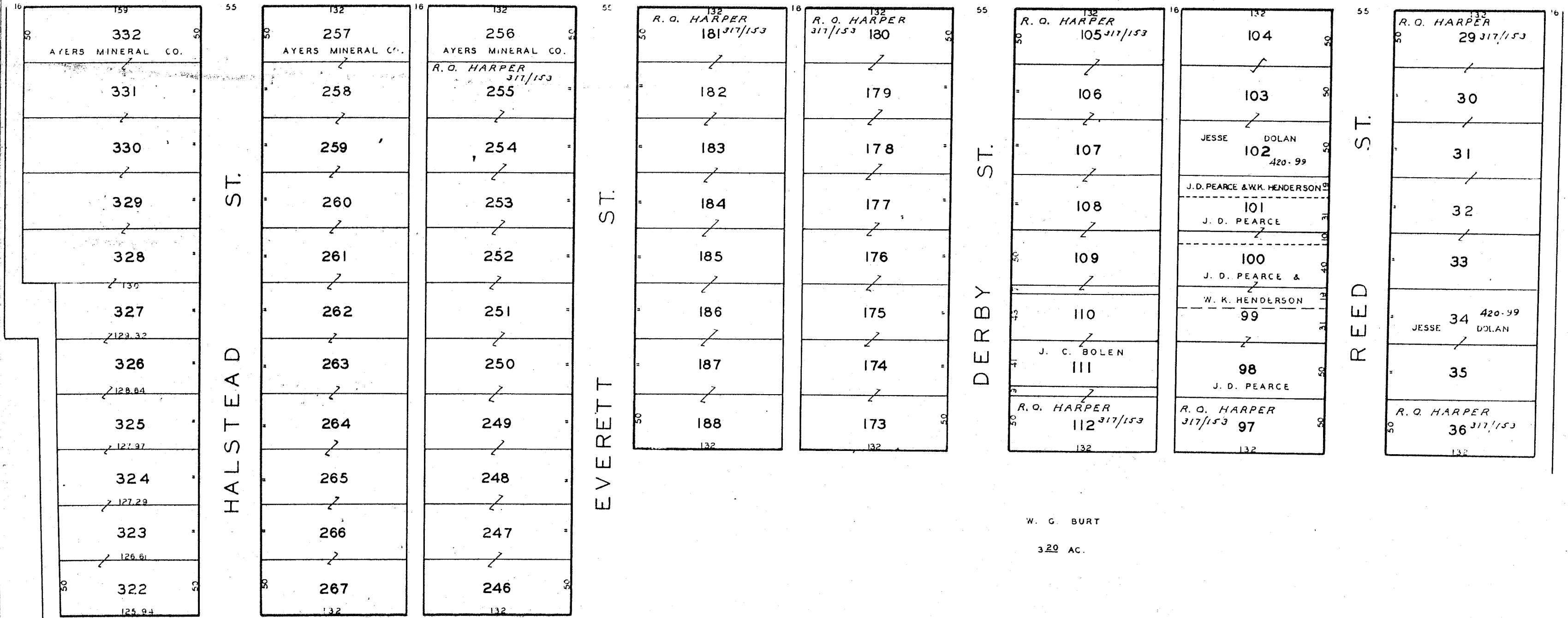
PART SO. ZANESVILLE CORP.
