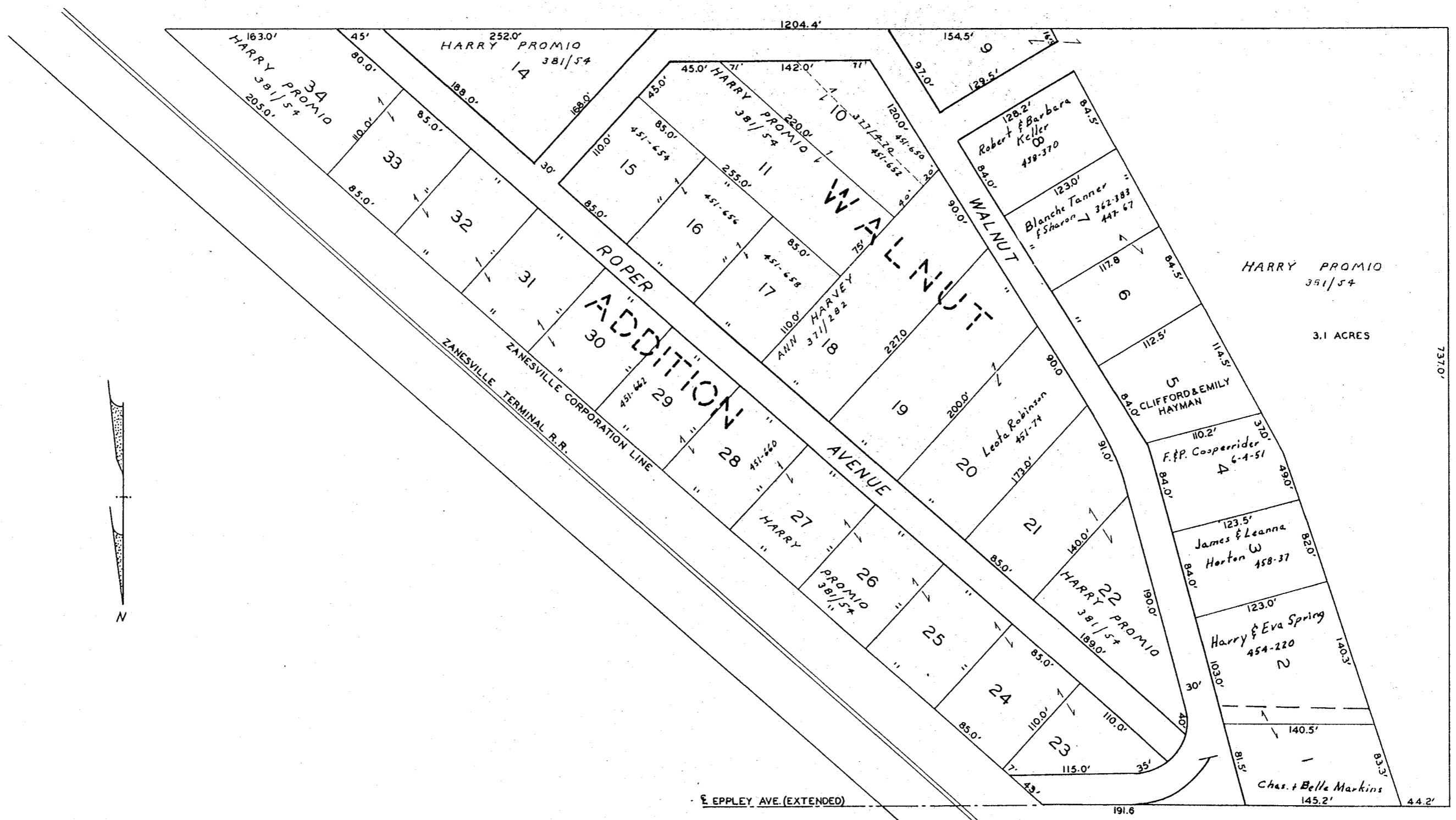
FRANKS SUB. NO'S 1 & 2
