All manhole and inlet/catch basin castings shall be ductile iron and meet the requirements of ASTM A48. All castings for sanitary sewer manholes shall be Neenah Foundry R-1916-F, subject to the County's approval, with top surface lettering "SANITARY SEWER", or equal. These castings are a permit requirement of the US Army Corps of Engineers. Unless otherwise shown on the drawings or specified in the SPECIAL PROVISIONS, standard storm sewer manhole castings shall be as shown on ODOT Standard Construction Drawing MH-3.

3. SECTION 12.2 - SECTION 1.6 MANHOLE AND INLET/CATCH BASIN CASTINGS

a. Page 473 of 477 (first paragraph)

REPLACE:

Standard manhole castings for sanitary sewer shall be Neenah Foundry R-1642 or R 1642-A, subject to the County's approval, with top surface alternate lettering "SEWER", or equal.

With:

Standard manhole castings for sanitary sewer shall be Neenah Foundry R-1916-F, subject to the County's approval, with top surface alternate lettering "SANITARY SEWER", or equal. These castings are a permit requirement of the US Army Corps of Engineers.
