TYPE OF SPECIAL HAULING PERMIT

• The POSTED ROAD (Annual) permit allows the holder to travel on all county roads that have been posted "30% Reduction" in weight limit within Muskingum County between January 25 and April 30, for the purpose of delivery/transport of: aggregate, concrete, asphalt, building supplies, refuse, construction equipment or material to a job site, agricultural equipment or material, or other goods or equipment hauled for any purpose that exceeds the "30% Reduction" in weight limit up to legal weight limits for the vehicle and load being transported. This permit DOES NOT ALLOW the use of any road crossing bridges that are posted at a lesser allowable tonnage than the weight of the permitted vehicle described on the permit.

SUBMITTAL/GENERAL INFORMATION

A SEPARATE PERMIT IS REQUIRED FOR EACH VEHICLE. NO PERMIT FEE IS REQUIRED. A COPY OF THE PERMIT SHOULD REMAIN WITH THE VEHICLE. *ANY ADDITIONAL PROVISIONS REQUIRED OF THE PERMIT HOLDER WILL BE ATTACHED TO THE PERMIT, BECOMING A COMPONENT PART OF THE PERMIT.*
