CONTINGENCY QUANTITIES:

THE CONTRACTOR SHALL NOT ORDER MATERIALS OR PERFORM WORK FOR ITEMS DESIGNATED BY PLAN NOTE TO BE USED "AS DIRECTED BY THE ENGINEER" UNLESS AUTHORIZED BY THE ENGINEER. THE ACTUAL WORK LOCATIONS AND QUANTITIES USED FOR SUCH ITEMS SHALL BE INCORPORATED INTO THE FINAL CHANGE ORDER GOVERNING COMPLETION OF THIS PROJECT.

CONSTRUCTION NOISE:

ACTIVITIES AND LAND USE ADJACENT TO THIS PROJECT MAY BE AFFECTED BY CONSTRUCTION NOISE. IN ORDER TO MINIMIZE ANY ADVERSE CONSTRUCTION NOISE IMPACTS, ANY POWER-OPERATED CONSTRUCTION-TYPE DEVICE SHALL NOT BE OPERATED BETWEEN THE HOURS OF 9 PM. AND 6 AM. IN ADDITION, ANY SUCH DEVICE SHALL NOT BE OPERATED AT ANY TIME IN SUCH A MANNER THAT THE NOISE CREATED SUBSTANTIALLY EXCEEDS THE NOISE CUSTOMARILY AND NECESSARILY ATTENDANT TO THE REASONABLE AND EFFICIENT PERFORMANCE OF SUCH EQUIPMENT.

WORK LIMITS:

THE WORK LIMITS SHOWN ON THESE PLANS ARE FOR PHYSICAL CONSTRUCTION ONLY. THE INSTALLATION AND OPERATION OF ALL TEMPORARY TRAFFIC CONTROL AND TEMPORARY TRAFFIC CONTROL DEVICES REQUIRED BY THESE PLANS SHALL BE PROVIDED BY THE CONTRACTOR WHETHER INSIDE OR OUTSIDE THESE WORK LIMITS.

NON-RUBBER TIRED VEHICLES:

ALL NON-RUBBER TIRED VEHICLES SHALL BE PROHIBITED FROM ANY ASPHALT OR CONCRETE STREET. EXCEPTIONS MAY BE GRANTED WHERE SHORT DISTANCES AND SPECIAL CIRCUMSTANCES ARE INVOLVED. REQUEST FOR AN EXCEPTION MUST BE MADE IN WRITING AND ANY DAMAGE OCCURRING SHALL BE REPAIRED TO THE SATISFACTION OF AND AT NO ADDITIONAL COST TO THE OWNER.

SAFETY REQUIREMENTS:

THE CONTRACTOR AND ALL SUBCONTRACTORS SHALL BE SOLELY RESPONSIBLE FOR COMPLYING WITH THE OCCUPATIONAL SAFETY AND HEALTH ACT OF 1970, OR THE MOST CURRENT VERSION THEREOF, DURING THE CONDUCT AND PERFORMANCE ON AND IN CONNECTION WITH THIS PROJECT.

SIGNS, DRAINAGE STRUCTURES, BUILDINGS, ETC.:

ALL SIGNS, DRAINAGE STRUCTURES, BUILDINGS, OR OTHER PHYSICAL FEATURES DISTURBED OR DAMAGED DURING WORK UNDER THIS CONTRACT SHALL BE RESTORED TO THEIR ORIGINAL CONDITION BY THE CONTRACTOR, AT NO ADDITIONAL COST TO THE OWNER.

ITEM 203 - LINEAR GRADING:

THIS WORK SHALL CONSIST OF SHAPING OR RESHAPING THE SHOULDER AS DIRECTED BY THE ENGINEER TO INSURE A SMOOTH DRAINABLE SURFACE FREE OF ALL IRREGULARITIES. EXCESS EXCAVATION RESULTING FROM THE SHOULDER WORK SHALL BE DISPOSED OF AS DIRECTED BY THE ENGINEER. PAYMENT FOR SHAPING OR RESHAPING THE GRADED SHOULDER AS DESCRIBED SHALL BE INCLUDED IN THE CONTRACT PRICE PER KILOMETER FOR ITEM 203, LINEAR GRADING.
