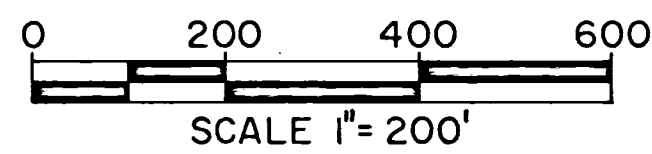


PROPERTY MAP

SEC. 15, T-12N, R-13W

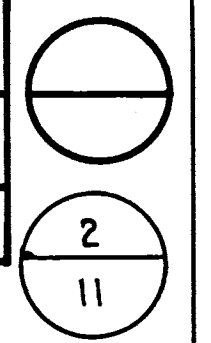
