Beginning at an iron pipe found at the Northwest corner of Lot 21 of the Village Gaysport; thence South  $66^{\circ} 00'$  East along the North line of Lot 21 165.00 feet to an iron pin set passing the center of Route 60 at 113.69 feet; thence South  $24^{\circ} 00'$  West along a 16.00 foot alley 132.00 feet to an iron pin set; thence north  $66^{\circ} 00'$  West along the South line of Lot 22 165.00 feet to an iron pin set passing the center of Route 60 at 58.12 feet; thence North  $24^{\circ} 00'$  East along the West line of Lots 22 and 21 132.00 feet to the place of beginning, being Lot 21 and 22 of the Village of Gaysport, containing 0.500 acres more or less. Except the right-of-way easement for State Route 60.

Parcel Two:

Beginning at an iron pipe found at the Northwest corner of Lot 21 of the Village of Gaysport; thence South  $24^{\circ} 00'$  West along the West line of Lots 21 and 22 and the North half of a 16.50 foot wide alley 140.25 feet to an iron pin set passing an iron pin set at 132.00 feet; thence North  $66^{\circ} 00'$  West 66.00 feet to a point; thence North  $24^{\circ} 00'$  East 140.25 feet to a point; thence South  $66^{\circ} 00'$  East 66.00 feet to the place of beginning, containing 0.213 acres more or less.




