

Re-Survey of Lots 21, 22, 23, and 24, East of Centerline of St. Rte. 60

Situated in the State of Ohio, County of Muskingum, Township of Blue Rock, and being part of the Lots 21, 22, 23 and 24, located east of the centerline of State Route 60 as per the Plat of Gaysport, as per Deed Record 17, Page 432, and being part of the lands presently owned by Carl W. Dearing, as per Official Record 1618, Page 77, and being more particularly described as follows:

Tract One

Beginning for reference and the principal place of beginning, at an iron pin found at the Southeast corner of Lot 20, of the Plat of Gaysport, as per Deed Record 17, Page 432;

Thence along the west line of an alley, and the east line of Lots 21, and 22, South 23 degrees 59 minutes 40 seconds West, 132.00 feet to an iron pin set, on the north line of an alley, and being the southeast corner of Lot 22;

Thence along the south line of said lot, and the north line of an alley, North 66 degrees 00 minutes 22 seconds West, 58.11 feet to a point in the centerline of State Route 60, (South River Road), passing an iron pin set at 28.06 feet;

Thence along said centerline, North 27 degrees 26 minutes 35 seconds East, 132.24 feet to a point on the north line of Lot 21, and the south line of lands presently owned by Bowen F. and Linda L. Van Cooney, (OR 2004-102);

Thence along the south line of said Van Cooney lands, and the north line of Lot 21, South 66 degrees 00 minutes 22 seconds East, 50.16 feet to the principal place of beginning, passing an iron pin set at 30.05 feet, containing 0.164 acres, more or less, of which 0.092 acres is in the right of way of State Route 60, and being all of Auditor's parcel number 06-42-02-22-000, +- 0.079 acres, (Lot 21), and all of Auditor's parcel number 06-42-02-24-000 +- 0.085 acres, (Lot 22).

Tract Two

Beginning for reference at an iron pin found at the Southeast corner of Lot 20, of the Plat of Gaysport, as per Deed Record 17, Page 432;

Thence along the west line of an alley, and the east line of Lots 21, and 22, South 23 degrees 59 minutes 40 seconds West, 148.50 feet to an iron pin set on the south line of an alley, (passing an iron pin set at 132.00 feet), and being the northeast corner of Lot 23, and the principal place of beginning;

Thence along the east line of Lots 23, and 24, and the west line of an alley, South 24 degrees 27 minutes 23 seconds West, 132.04 feet to an iron pin found on the northeast corner of lands presently owned by Michael J. McClelland, and Garnet V. Anderson, (OR 2398-466), and the south line of Lot 24;

Thence along the south line of said lot, and the north line of McClelland, and Anderson lands, North 65 degrees 39 minutes 46 seconds West, 65.99 feet to a point in the centerline of State Route 60, passing an iron pin found at 37.15 feet;

Thence along said centerline, North 27 degrees 26 minutes 35 seconds East, 131.88 feet to a

point on the north line of Lot 23, and the south line of an alley;

Thence along the south line of said alley, and the north line of Lot 23, South 66 degrees 00 minutes 22 seconds East, 59.11 feet to the principal place of beginning, passing an iron pin set at 30.05 feet, containing 0.189 acres, more or less, of which 0.091 acres is in the right of way of State Route 60, and being all of Auditor's parcel number 06-42-02-25-001, +- 0.189 acres, (Lots 23, and 24).

Subject to all legal recorded easements and right of ways.

Iron pins set are 5/8 inch rebars, 30 inches long, with plastic identification caps.

Bearings are based on an assumed north meridian, and are for angular calculations only.

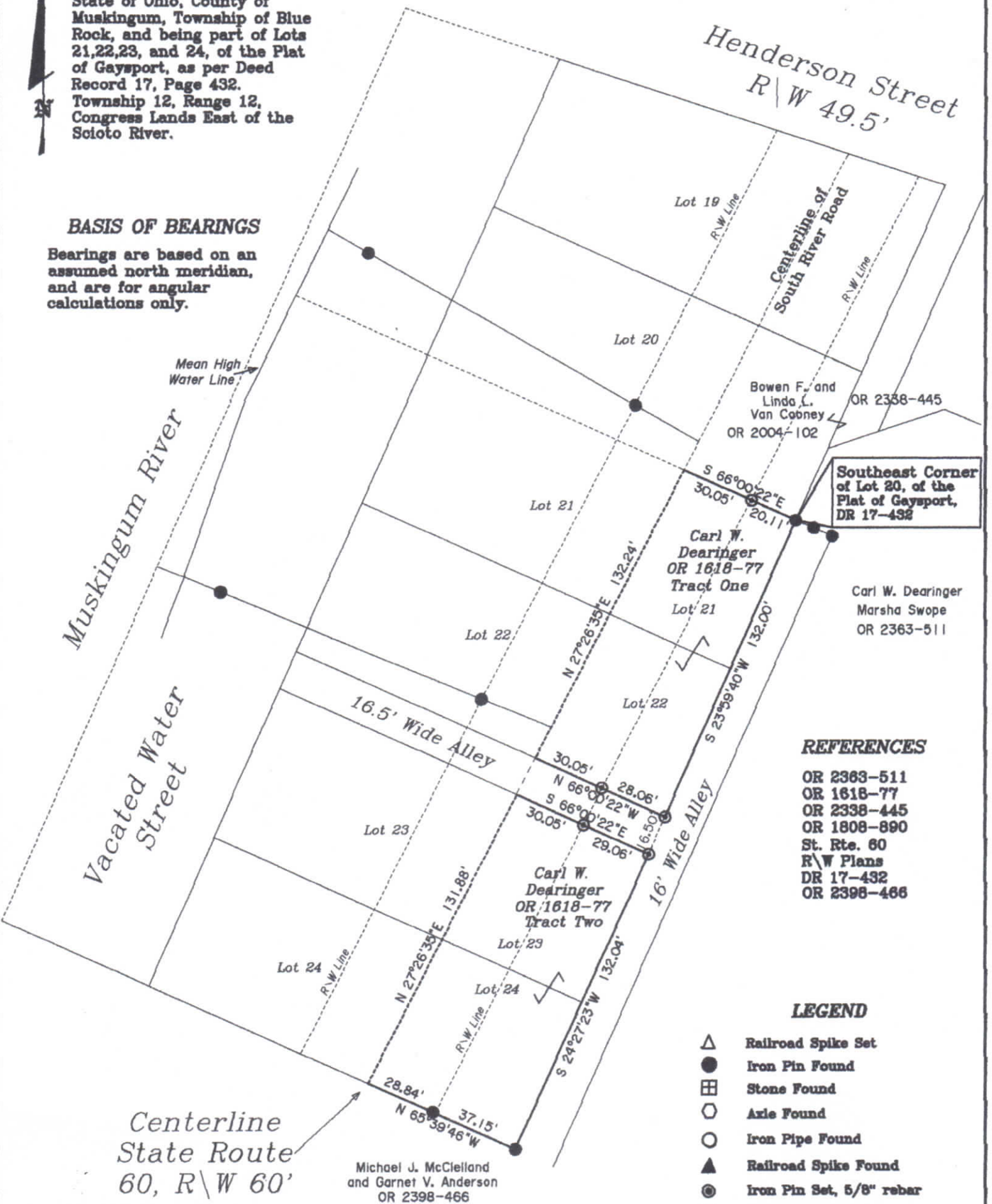


SITUATED IN:

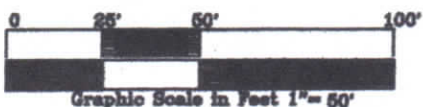
