Commencing at the Northeast corner of the said West half of the Southeast Quarter; thence North 89 degrees 11 minutes 20 seconds West 270.59 feet to a point in the center of a township road (The Flats), said point being the place of beginning of this tract; thence South 26 degrees 53 minutes 47 seconds East 180.00 feet to a point in the said center; thence leaving said road North 89 degrees 11 minutes 20 seconds West 315.19 feet to an iron pin set, passing an iron pin set at 20.00 feet; thence North 00 degrees 48 minutes 40 seconds East 159.36 feet to an iron pin set in Old Township Road Number 378; thence South 89 degrees 11 minutes 20 seconds East 231.50 feet to the place of beginning, passing an iron pin set at 211.50 feet.




