

Being a Survey of a part of a 42.83 Acre parcel conveyed to Countrytyme Land, LLC, as recorded in O.R. 2576, Page 439, in the Muskingum County Deed Records, and being part of Auditor's Parcel No. 06-60-23-07-000, and further described as follows;

Commencing at a stone found marking the Southwest corner of the Southeast Quarter of Section 23, being the Southwest corner of said parcel conveyed to Countrytyme Land, LLC of which this description is a part, also being the Southeast corner of a parcel conveyed to Kenneth L. Karns, Jr., as recorded in O.R. 2198, Page 876, being on the North line of a parcel conveyed to Frame Farm Partnership, LLC, as recorded in O.R. 2473, Page 532, and being the **PRINCIPAL PLACE OF BEGINNING** of the 22.826 Acre parcel herein to be described;

Thence, **N 02°05'00" W 988.42 feet** with the North-South Half Section Line of Section 23, the same being the West line of said parcel conveyed to Countrytyme Land, LLC of which this description is a part, also being the East line of said parcel conveyed to Karns, to a mag nail set in the centerline of Imlay Road, and passing over an iron pin set at 958.42 feet;






