BEING A PART OF LOT 1 OF A SURVEY BY CHARLES ROBERTS IN MARCH 1834, SITUATED IN THE NORTHEAST QUARTER OF SECTION 29, TOWNSHIP 12, RANGE 12, OF THE CONGRESS LANDS EAST OF THE SCIOTO RIVER, BLUE ROCK TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

BEGINNING AT AN EXISTING IRON PIN (1/2 INCH REBAR-CLAUS) AT THE NORTHEAST CORNER OF THE SAID NORTHEAST QUARTER;

THENCE WITH THE EAST LINE OF THE SAID NORTHEAST QUARTER, SOUTH 00 DEGREES 46 MINUTES 35 SECONDS EAST 271.54 FEET TO AN IRON PIN SET;

THENCE LEAVING THE EAST LINE OF THE SAID NORTHEAST QUARTER AND TRAVERSING THROUGH THE TRACT CONVEYED TO CAROL GOFF (VOLUME, PAGE), SOUTH 44 DEGREES 57 MINUTES 54 SECONDS WEST 1977.00 FEET TO A POINT IN COUNTY ROAD 466 (GAYSPORT HILL ROAD), PASSING IRON PINS SET AT 1515.91 FEET AND AT 1950.50 FEET;

THENCE WITH THE CENTER OF COUNTY ROAD 466 (GAYSPORT HILL ROAD) THE FOLLOWING SEVEN COURSES AND DISTANCES;

- 1) NORTH 39 DEGREES 42 MINUTES 14 SECONDS WEST 24.22 FEET TO A POINT;
- 2) NORTH 32 DEGREES 19 MINUTES 25 SECONDS WEST 55.99 FEET TO A POINT;
- 3) NORTH 22 DEGREES 02 MINUTES 37 SECONDS WEST 54.37 FEET TO A POINT;
- 4) NORTH 16 DEGREES 26 MINUTES 05 SECONDS WEST 53.82 FEET TO A POINT;
- 5) NORTH 12 DEGREES 45 MINUTES 23 SECONDS WEST 286.92 FEET TO A POINT;
- 6) NORTH 11 DEGREES 16 MINUTES 49 SECONDS WEST 59.73 FEET TO A POINT;
- 7) NORTH 34 DEGREES 46 MINUTES 27 SECONDS WEST 3.18 FEET TO A POINT;

THENCE LEAVING THE CENTER OF COUNTY ROAD 466 (GAYSPORT HILL ROAD) AND TRAVERSING THROUGH SAID GOFF TRACT, SOUTH 64 DEGREES 58 MINUTES 07 SECONDS WEST 402.56 FEET TO AN IRON PIN SET, PASSING AN IRON PIN SET AT 65.62 FEET;

THENCE NORTH 42 DEGREES 41 MINUTES 47 SECONDS WEST 380.95 FEET TO AN IRON PIN SET;

THENCE NORTH 65 DEGREES 55 MINUTES 26 SECONDS EAST 349.66 FEET TO A POINT IN THE CENTER OF COUNTY ROAD 466 (GAYSPORT HILL ROAD), PASSING AN IRON PIN SET AT 320.33 FEET;

THENCE WITH THE CENTER OF COUNTY ROAD 466 (GAYSPORT HILL ROAD), NORTH 54 DEGREES 13 MINUTES 24 SECONDS WEST 440.54 FEET TO A POINT;

THENCE LEAVING THE CENTER OF COUNTY ROAD 466 (GAYSPORT HILL ROAD) AND TRAVERSING THROUGH SAID GOFF TRACT, NORTH 27 DEGREES 31 MINUTES 49 SECONDS EAST 701.09 FEET TO AN IRON PIN SET ON THE NORTH LINE OF SECTION 29, PASSING IRON PINS SET AT 41.97 FEET AND AT 412.29 FEET;

THENCE WITH THE SAID SECTION LINE, NORTH 89 DEGREES 06 MINUTES 17 SECONDS EAST 1174.70 FEET TO AN IRON PIN SET AT THE SOUTHWEST CORNER OF TRACT 10 OF A SURVEY FOR BRUNER LAND COMPANY (DATED MAY 5, 1988);

THENCE CONTINUING WITH THE SAID SECTION LINE, NORTH 89 DEGREES 04 MINUTES 58 SECONDS EAST 714.03 FEET TO THE PLACE OF BEGINNING.

CONTAINING 50.000 MORE OR LESS ACRES, SUBJECT TO ALL LEGAL ROAD RIGHT OF WAYS OF COUNTY ROAD 466 AND ALL OTHER APPLICABLE EASEMENTS.




