Being a part of Section 34, Township 12, Range 12 bounded and described as follows:

Beginning at a stone at the Southwest corner of Section 34; thence north 0 degrees 21 minutes 05 seconds west 1336 feet to a corner post; thence south 89 degrees 47 minutes 43 seconds east 2555.40 feet to an iron pin in the center of Peyton Road; thence along said road north 16 degrees 03 minutes 37 seconds east 98.87 feet to a point; thence continuing along said road north 29 degrees 16 minutes east 256.74 feet to an iron pin; thence leaving said road south 85 degrees 33 minutes 22 seconds east 721.13 feet to a corner post; thence south 0 degrees 48 minutes 25 seconds west 1589.62 feet to a corner post; thence south 89 degrees 59 minutes 25 seconds west 3396.69 feet to the place of beginning, containing one hundred and nine and fifty-four hundredths (109.54) acres more or less.





Subject to the easements of Peyton Road.



CORNER SECTION 34


