COMMENCING AT THE SOUTHWEST CORNER OF NORTHEAST QUARTER OF ABOVE SAID SECTION #7; THENCE SOUTH 85 DEGREES - 00 MINUTES - 00 SECONDS - EAST, 1250.00 FEET TO A POINT AT THE LOW WATER MARK OF THE MUSKINGUM RIVER, THENCE NORTH 47 DEGREES - 12 MINUTES - 35 SECONDS WEST, 167.07 FEET TO A POINT IN THE CENTER OF A CONCRETE BRIDGE ABUTMENT IN THE CENTERLINE EXTENDED OF STOVERTOWN RD. (OLD STATE ROUTE 555) AND THE TRUE POINT OF BEGINNING FOR THE PROPERTY HEREIN INTENDED TO BE DESCRIBED. THENCE SOUTH 32 DEGREES - 05 MINUTES - 54 SECONDS WEST, 509.52 FEET ALONG THE CENTER OF SAID ROAD TO A POINT ON THE NORTHERLY LINE OF THE O. & L. K. RAILROAD. THENCE ALONG THE NORTHERLY LINE THEREOF NORTH 51 DEGREES - 38 MINUTES - 47 SECONDS WEST, 308.10 FEET TO A POINT. 

COMMENCING AT THE SOUTHWEST CORNER OF THE NORTHEAST QUARTER OF SAID SECTION 7, THENCE, SOUTH 85 DEGREES - 00 MINUTES - 00 SECONDS EAST, 1250.00 FEET TO A POINT; THENCE, NORTH 47 DEGREES - 12 MINUTES - 35 SECONDS WEST, 167.07 FEET TO A POINT IN THE CENTER OF A CONCRETE BRIDGE ABUTMENT IN THE CENTERLINE EXTENDED OF STOVERTOWN ROAD (OLD STATE ROUTE 555); THENCE, NORTH 53 DEGREES - 24 MINUTES - 50 SECONDS WEST, 85.23 FEET TO A POINT ON THE SOUTH BANK OF THE MUSKINGUM RIVER, AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, SOUTH 40 DEGREES - 42 MINUTES - 41 SECONDS WEST, 475.56 FEET TO AN IRON PIN SET ON THE NORTH LINE OF THE O. & L. K. RAILROAD RIGHT-OF-WAY, PASSING AN IRON PIN SET AT 99.70 FEET ON THE SOUTH LINE OF COUNTY ROAD 6; THENCE, ALONG SAID RIGHT-OF-WAY, NORTH 50 DEGREES - 07 MINUTES - 08 SECONDS WEST, 158.58 FEET TO A POINT; THENCE, NORTH 41 DEGREES - 48 MINUTES - 48 SECONDS EAST, 467.15 FEET TO A POINT ON THE SOUTH BANK OF SAID MUSKINGUM RIVER, PASSING IRON PIPES FOUND AT 234.60 FEET AND 387.15 FEET; THENCE, SOUTH 53 DEGREES - 24 MINUTES - 50 SECONDS EAST, 149.97 FEET TO THE POINT OF BEGINNING, AND CONTAINING 1.666 ACRES MORE OR LESS.


